30	more shall operate or drive only in the far right lane, except when:

33	the roadway or to merge onto the roadway from an entrance ramp;	
34	(3) Using an alternate lane is required for safety reasons because of

All provisions of this act of general and permanent nature 2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 3 Revision Commission shall incorporate the same in the Code.
