It is hereby found and determined by the General Assembly 13 14 that Act 1211 of 1995 established the procedure for all state boards and 15 commissions to follow regarding reimbursement of expenses and stipends for 16 board members; that this act amends various sections of the Arkansas Code 17 which are in conflict with the Act 1211 of 1995; and that until this cleanup 18 act becomes effective conflicting laws will exist. Therefore an emergency is 19 declared to exist and this act being immediately necessary for the 20 preservation of the public peace, health and safety shall become effective on 21 the date of its approval by the Governor. If the bill is neither approved nor 22 vetoed by the Governer, it shall become effective on the expiration of the 23 period of time during which the Governor may veto the bill.
