20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	SECTION 1. Arkansas Code § 19-11-206 is amended to read as follows:
23	"19-11-206. Definitions concerning intergovernmental relations.
24	As used in this subchapter, unless the context otherwise requires:
25	(1) _State public procurement unit_ means the Office of State
26	Purchasing and any other purchasing agency of this state;
27	(2) _Local public procurement unit_ means any county, city, town, state
28	agency, and any other subdivision of the state or public agency thereof; any
29	fire protection district; regional water distribution district; rural
30	development authority; any public authority; any public educational, health,
31	or other institution; any nonprofit corporation during such time that it
32	contracts with the Division of Developmental Disabilities Services of the
33	Arkansas Department of Human Services to provide services to the
34	developmentally disabled, provided such contract exceeds seventy-five thousand
35	dollars (\$75,000) per year; any nonprofit corporation providing fire
36	protection services to a rural area or providing drinking water to the public

- 1 in a rural area; and, to the extent not prohibited by law, any other entity
- 2 which expends public funds for the acquisition or leasing of commodities and
- 3 services;
- 4 (3) _Public procurement unit_ means either a local public procurement
- 5 unit or a state public procurement unit;
- 6 (4) _External procurement activity_ means any buying organization not
- 7 located in this state which, if located in this state, would qualify as a
- 8 public procurement unit. An agency of the federal government is an external
- 9 procurement activity; and
- 10 (5) _Cooperative purchasing_ means procurement conducted by, or on
- 11 behalf of, more than one (1) public procurement unit or by a public
- 12 procurement unit with an external procurement activity."

- 14 SECTION 2. All provisions of this act of general and permanent nature
- 15 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 16 Revision Commission shall incorporate the same in the Code.

- 18 SECTION 3. If any provisions of this act or the application thereof to
- 19 any person or circumstance is held invalid, the invalidity shall not affect
- 20 other provisions or applications of the act which can be given effect without
- 21 the invalid provisions or application, and to this end the provisions of this
- 22 act are declared to be severable.

- 24 SECTION 4. All laws and parts of laws in conflict with this act are
- 25 hereby repealed.
