22	law to the contrary, windshields of law enforcement vehicles may be tinted	<u>to</u>
23	the extent that the windshield permits at least fifty percent (50%) net light	<u>ht</u>
24	transmission."

26	SECTION 2. All provisions of this act of a general and permanent natu	ure
27	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code	
28	Revision Commission shall incorporate the same in the Code.

30	SECTION 3. If any provision of this act or the application thereof to	0
31	any person or circumstance is held invalid, such invalidity shall not affect	t
32	other provisions or applications of the act which can be given effect without	ut
33	the invalid provision or application, and to this end the provisions of this	S
34	act are declared to be severable.

36	SECTION 4. All laws and parts of laws in conflict with this act are	

1 hereby repealed. 3 SECTION 5. EMERGENCY. It is hereby found and determined by the General 4 Assembly that the tinting of windshields of law enforcement vehicles should be 5 permitted to the extent provided by this act; and that until this act goes 6 into effect the prohibition of current law will be an undue restriction upon 7 the law enforcement agencies of this state. Therefore an emergency is 8 declared to exist and this act being immediately necessary for the 9 preservation of the public peace, health and safety shall become effective on 10 the date of its approval by the Governor. If the bill is neither approved nor 11 vetoed by the Governor, it shall become effective on the expiration of the 12 period of time during which the Governor may veto the bill.
