30	SECTION 6. LEGISLATIVE INTENT. It is the intent of the General							
31	Assembly that any funds disbursed under the authority of the appropriations							
32	contained in this Act shall be in compliance with the stated reasons for which							
33	this Act was adopted, as evidenced by the Agency Requests, Executive							
34	Recommendations and Legislative Recommendations contained in the budget							
35	manuals prepared by the Department of Finance and Administration, letters, or							

1 summarized oral testimony in the official minutes of the Arkansas Legislative 2 Council or Joint Budget Committee which relate to its passage and adoption. SECTION 7. CODE. All provisions of this Act of a general and permanent 4 5 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 6 Code Revision Commission shall incorporate the same in the Code. SECTION 8. SEVERABILITY. If any provision of this Act or the 9 application thereof to any person or circumstance is held invalid, such 10 invalidity shall not affect other provisions or applications of the Act which 11 can be given effect without the invalid provision or application, and to this 12 end the provisions of this Act are declared to be severable. 13 SECTION 9. GENERAL REPEALER. All laws and parts of laws in conflict 14 15 with this Act are hereby repealed. 16 17 SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the 18 Eighty-First General Assembly, that the Constitution of the State of Arkansas 19 prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1997 is essential to the operation of 2.0 21 the agency for which the appropriations in this Act are provided, and that in 22 the event of an extension of the Regular Session, the delay in the effective 23 date of this Act beyond July 1, 1997 could work irreparable harm upon the 24 proper administration and provision of essential governmental programs. 25 Therefore, an emergency is hereby declared to exist and this Act being 26 necessary for the immediate preservation of the public peace, health and 27 safety shall be in full force and effect from and after July 1, 1997. 28 /s/JBC 29 30 31 32 33 34 35
