24	SECTION 1. Arkansas Code annotated § 6-20-1607 is amen	ded to read a	as
25	follows:		
26	"6-20-1607. Classification of school districts in distr	ess.	
27	(a)(1) During the 1997-98 school year, and each school	year thereaf	Eter,
28	the department shall determine which school districts shall b	e classified	as
29	Phase I districts or Phase II districts.		
30	(2) A school district may be classified a Phase	I district fo	or
31	more than one (1) year.		
32	(3) No Phase I or Phase II district shall incur	additional de	<u>ebt</u>
33	without the approval of the Department of Education.		
34	(b) During the 1997-98 school year, and each school ye	ar thereafter	£ ,
35	only those districts classified as Phase II districts by the	Director of t	the

36 General Education Division of the Department of Education shall be required to

- 1 receive on-site technical assistance by a team of educators assigned by the
- 2 department to work directly with the districts.
- 3 (c) During the first six (6) months of the school year in which a
- 4 district is classified as a Phase II district, the department team shall
- 5 evaluate and make recommendations to the district superintendent regarding the
- 6 staffing of the district and concerning fiscal or academic policies or
- 7 practices of the district, if necessary to address the fiscal or academic
- 8 distress of the district as defined by the department.
- 9 (d) The recommendations of the department shall be binding on the
- 10 district, the superintendent, and the school board; provided, however, that it
- 11 shall be the duty of the district to follow all Arkansas laws.
- 12 (e) A district classified as a Phase II school district that fails to
- 13 follow recommendations of the department shall be immediately classified as a
- 14 Phase III school district.
- 15 (f) At the conclusion of the 1997-98 school year, and each year
- 16 thereafter, the department shall report the progress of all districts
- 17 classified as Phase II school districts to the State Board of Education."

- 19 SECTION 2. All provisions of this act of a general and permanent nature
- 20 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 21 Revision Commission shall incorporate the same in the Code.

- 23 SECTION 3. If any provision of this act or the application thereof to
- 24 any person or circumstance is held invalid, such invalidity shall not affect
- 25 other provisions or applications of the act which can be given effect without
- 26 the invalid provision or application, and to this end the provisions of this
- 27 act are declared to be severable.

- 29 SECTION 4. All laws and parts of laws in conflict with this act are
- 30 hereby repealed.
