11 TECH FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1999; AND FOR  
12 OTHER PURPOSES."

15 "AN ACT FOR THE SOUTHERN ARKANSAS  
16 UNIVERSITY - TECH APPROPRIATION FOR THE  
17 1997-99 BIENNIUM."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. REGULAR SALARIES. There is hereby established for the  
22 Southern Arkansas University - TECH for the 1997-99 biennium, the following  
23 maximum number of regular employees whose salaries shall be governed by the  
24 provisions of the Uniform Classification and Compensation Act (Arkansas Code  
25 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.  
26 Provided, however, that any position to which a specific maximum annual salary  
27 is set out herein in dollars, shall be exempt from the provisions of said  
28 Uniform Classification and Compensation Act. All persons occupying positions  
29 authorized herein are hereby governed by the provisions of the Regular  
30 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its  
31 successor.

10 SECTION 9. SPECIAL LANGUAGE. DECLARED EMERGENCY - TRANSFER OF

11 APPROPRIATIONS. At any time when the Governor of the State of Arkansas

12 declares that an emergency exists, and the Southern Arkansas University-Tech,

13 Fire Training Academy is required to lend assistance, the Southern Arkansas

14 University-Tech, Fire Training Academy will be authorized to make transfers of

15 appropriation, either General Revenue or Cash, and further, that no such

16 transfer will increase the total amount appropriated for the Southern Arkansas

17 University-Tech, Fire Training Academy.

4 SECTION 14. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 5 authorized by this Act shall be limited to the appropriation for such agency  
 6 and funds made available by law for the support of such appropriations; and  
 7 the restrictions of the State Purchasing Law, the General Accounting and  
 8 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 9 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions  
 10 Act, or their successors, and other fiscal control laws of this State, where  
 11 applicable, and regulations promulgated by the Department of Finance and  
 12 Administration, as authorized by law, shall be strictly complied with in  
 13 disbursement of said funds.

14

15 SECTION 15. LEGISLATIVE INTENT. It is the intent of the General  
 16 Assembly that any funds disbursed under the authority of the appropriations  
 17 contained in this Act shall be in compliance with the stated reasons for which  
 18 this Act was adopted, as evidenced by the Agency Requests, Executive  
 19 Recommendations and Legislative Recommendations contained in the budget  
 20 manuals prepared by the Department of Finance and Administration, letters, or  
 21 summarized oral testimony in the official minutes of the Arkansas Legislative  
 22 Council or Joint Budget Committee which relate to its passage and adoption.

23

24 SECTION 16. CODE. All provisions of this Act of a general and  
 25 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and  
 26 the Arkansas Code Revision Commission shall incorporate the same in the Code.

27

28 SECTION 17. SEVERABILITY. If any provision of this Act or the  
 29 application thereof to any person or circumstance is held invalid, such  
 30 invalidity shall not affect other provisions or applications of the Act which  
 31 can be given effect without the invalid provision or application, and to this  
 32 end the provisions of this Act are declared to be severable.

33

34 SECTION 18. GENERAL REPEALER. All laws and parts of laws in conflict  
 35 with this Act are hereby repealed.

1

2       SECTION 19. EMERGENCY CLAUSE. It is hereby found and determined by the  
3 Eighty-First General Assembly, that the Constitution of the State of Arkansas  
4 prohibits the appropriation of funds for more than a two (2) year period; that  
5 the effectiveness of this Act on July 1, 1997 is essential to the operation of  
6 the agency for which the appropriations in this Act are provided, and that in  
7 the event of an extension of the Regular Session, the delay in the effective  
8 date of this Act beyond July 1, 1997 could work irreparable harm upon the  
9 proper administration and provision of essential governmental programs.  
10 Therefore, an emergency is hereby declared to exist and this Act being  
11 necessary for the immediate preservation of the public peace, health and  
12 safety shall be in full force and effect from and after July 1, 1997.
