19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. REGULAR SALARIES. There is hereby established for the
22 Arkansas Industrial Development Commission for the 1997-99 biennium, the
23 following maximum number of regular employees whose salaries shall be governed
24 by the provisions of the Uniform Classification and Compensation Act (Arkansas
25 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
26 Provided, however, that any position to which a specific maximum annual salary
27 is set out herein in dollars, shall be exempt from the provisions of said
28 Uniform Classification and Compensation Act. All persons occupying positions
29 authorized herein are hereby governed by the provisions of the Regular
30 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
31 successor.

 29 Professionals, and the necessity of recruiting and retaining qualified
 30 personnel, the Arkansas Industrial Development Commission is authorized
 31 special rates of pay for current and new employees up to levels listed under
 32 subsection (b) below. Special rates of pay may be requested subject to the
 33 following restrictions:

34 (a) that applications for special rates of pay shall have been reviewed
 35 and approved by the Office of Personnel Management after seeking prior review

1 by the Arkansas Legislative Council or Joint Budget Committee.

2 (b) that special rates may be authorized for the following
3 classifications only, as indicated herein:

11 SECTION 23. SPECIAL LANGUAGE. TRANSFER PROVISION - FOREIGN OFFICES. If
 12 at any time during the 1997-99 biennium, the Director determines that market
 13 conditions warrant, the Arkansas Industrial Development Commission is hereby
 14 authorized to transfer appropriation, after receiving the approval of the
 15 Chief Fiscal Officer of the State and prior review by the Arkansas Legislative
 16 Council or Joint Budget Committee, between any of the three Foreign Offices
 17 (European Trade, Far East Trade/Industrial Recruitment and Latin American
 18 Trade Development) in Section 3 of this Act for the purpose of responding to
 19 changes in the world markets.

20

21 SECTION 24. SPECIAL LANGUAGE. TRANSFER PROVISION. If at any time during
 22 the 1997-99 biennium, savings are accomplished in the appropriation provided
 23 for "European Trade", "Far East Trade/Industrial Recruitment", "Latin American
 24 Trade", and "Regular Salaries" in Section 3 of this Act, such appropriation
 25 savings may be transferred to the appropriations made for "Maintenance and
 26 General Operations" in Section 3 of this Act after prior review by the
 27 Arkansas Legislative Council or Joint Budget Committee. In addition, if at
 28 any time during the 1997-99 biennium, savings are accomplished in the
 29 appropriation provided for "Maintenance and General Operations" in Section 3
 30 of this Act, such appropriation savings may be transferred to the
 31 appropriation for "European Trade" and "Far East Trade/Industrial Recruitment"
 32 and "Latin American Trade" in Section 3 of this Act, after prior review by the
 33 Arkansas Legislative Council or Joint Budget Committee.

34

35 SECTION 25. SPECIAL LANGUAGE. CARRY FORWARD. The unexpended balances of

1 appropriation provided for the expenditures of federal funds as provided for
2 in Section 5 of this Act on June 30, 1998, shall be carried forward and made
3 available for expenditures for the same purpose for the fiscal year ending
4 June 30, 1999.

5
6 SECTION 26. SPECIAL LANGUAGE. TRANSFER PROVISION. After receiving
7 approval from the Chief Fiscal Officer of the State and prior review by the
8 Arkansas Legislative Council or Joint Budget Committee, the Director of the
9 Arkansas Industrial Development Commission is authorized to transfer
10 appropriation from any line item appropriation authorized in Section 5 of this
11 Act to any other line item authorized in Section 5 of this Act and any line
12 item appropriation authorized in Section 4 of this Act to any other line item
13 authorized in Section 4 of this Act.

14
15 SECTION 27. SPECIAL LANGUAGE. The flexibility provided to the Arkansas
16 Industrial Development Commission by Section 25 and Section 26 of this Act
17 shall be used only when necessary to carry out the Community Development Block
18 Grant Program.

19
20 SECTION 28. SPECIAL LANGUAGE. There is hereby established a pool of
21 thirteen (13) positions entitled State Economic Developer III to be assigned
22 to the Arkansas Industrial Development Commission which will be used to
23 reclassify personnel from State Economic Developer I and/or State Economic
24 Developer II. To obtain a position from the pool, the Arkansas Industrial
25 Development Commission must seek a review by the Arkansas Legislative Council
26 or Joint Budget Committee, obtain approval from the Office of Personnel
27 Management and must surrender the position being reclassified to the pool.
28 This will ensure that the total positions available to be filled does not
29 exceed the number authorized in the Agency's appropriation Act.

30
31 SECTION 29. SPECIAL LANGUAGE. CARRY FORWARD. At the close of the fiscal
32 year ending June 30, 1998, any unexpended appropriation provided for the
33 Century Tube Scholarship Program shall be carried forward and made available
34 for the same purposes for the fiscal year ending June 30, 1999.

35

1 SECTION 30. SPECIAL LANGUAGE. CARRY FORWARD. At the close of the fiscal
2 year ending June 30, 1998, any unexpended appropriation provided in the line
3 item entitled "Train the Trainer Program" shall be carried forward and made
4 available for the same purposes for the fiscal year ending June 30, 1999.

5
6 SECTION 31. SPECIAL LANGUAGE. In addition to training expenses, funds made
7 available to support the appropriation in Item (06) of Section 16 herein shall
8 be used to acquire capital equipment necessary to enhance the quick-start
9 capabilities of the Arkansas Industry Training Programs. When not in use in
10 an AITP managed course of training, the equipment shall be stored at a
11 location to be determined by the Executive Director, AIDC.

12
13 SECTION 32. SPECIAL LANGUAGE. FOREIGN OFFICE OPERATIONS. The Arkansas
14 Industrial Development Office is hereby authorized to enter into contractual
15 arrangements with private and/or public companies, corporations or
16 organizations for the purpose of operating foreign offices. Payment for such
17 contractual arrangements for operations may be made from the special line
18 items established by legislative appropriation for the operation of foreign
19 offices. At such time as any of the foreign offices are being operated under
20 such a contractual arrangement, no Overseas Program personnel as authorized by
21 Arkansas Code 15-4-211 shall be employed concurrently with a contractual
22 arrangement with a company, corporation or organization. Arkansas Code 15-4-
23 211 shall not be deemed restrictive in its language so as to preclude the use
24 of standard Professional Services Contracts for the operation of the foreign
25 offices and/or payment of such contracts from the special line items as
26 established by legislative appropriation for the operation of said foreign
27 offices.

28
29 SECTION 33. SPECIAL LANGUAGE. TRANSFER PROVISION - INDUSTRY TRAINING. If
30 during either year of the 1997-99 fiscal biennium, the Industry Training
31 Division effects savings in Item (06), Industry Training Program Expenses, of
32 Section 16 of this Act, such savings may be transferred to item (02), Extra
33 Help or item (05), Maintenance and General Operations, of Section 16 of this
34 Act, after obtaining approval of the Chief Fiscal Officer of the State and
35 after prior review by the Arkansas Legislative Council or Joint Budget

1 Committee. In addition, if any savings are effected in either year of the
 2 1997-99 fiscal biennium in item (05), Maintenance and General Operations, of
 3 Section 16 of this Act, such savings may be transferred to item (06), Industry
 4 Training Program Expenses, of Section 16 of this Act, after obtaining approval
 5 of the Chief Fiscal Officer of the State and after prior review by the
 6 Arkansas Legislative Council or Joint Budget Committee.

7
 8 SECTION 34. SPECIAL LANGUAGE. TRANSFER PROVISION - INDUSTRY TRAINING
 9 PROGRAM. During either fiscal year of the 1997-99 biennium, any savings
 10 accomplished in line item (02) of Section 16 of this Act, Extra Help, may be
 11 transferred to line item (05) of Section 16 of this Act, Maintenance and
 12 General Operation after prior review by the Arkansas Legislative Council or
 13 Joint Budget Committee.

14
 15 SECTION 35. APPROPRIATIONS. *There is hereby appropriated, to the*
 16 *Arkansas Industrial Development Commission, to be payable from the Department*
 17 *of Industrial Development Fund Account, for personal services and operating*
 18 *expenses of the Arkansas Industrial Development Commission - Motion Picture*
 19 *Office for the biennial period ending June 30, 1999, the following:*

 32 SECTION 36. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
 33 by this Act shall be limited to the appropriation for such agency and funds
 34 made available by law for the support of such appropriations; and the
 35 restrictions of the State Purchasing Law, the General Accounting and Budgetary

1 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
2 and Restrictions Act, or their successors, and other fiscal control laws of
3 this State, where applicable, and regulations promulgated by the Department of
4 Finance and Administration, as authorized by law, shall be strictly complied
5 with in disbursement of said funds.

6

7 SECTION 37. LEGISLATIVE INTENT. It is the intent of the General Assembly
8 that any funds disbursed under the authority of the appropriations contained
9 in this Act shall be in compliance with the stated reasons for which this Act
10 was adopted, as evidenced by the Agency Requests, Executive Recommendations
11 and Legislative Recommendations contained in the budget manuals prepared by
12 the Department of Finance and Administration, letters, or summarized oral
13 testimony in the official minutes of the Arkansas Legislative Council or Joint
14 Budget Committee which relate to its passage and adoption.

15

16 SECTION 38. CODE. All provisions of this Act of a general and permanent
17 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
18 Code Revision Commission shall incorporate the same in the Code.

19

20 SECTION 39. SEVERABILITY. If any provision of this Act or the
21 application thereof to any person or circumstance is held invalid, such
22 invalidity shall not affect other provisions or applications of the Act which
23 can be given effect without the invalid provision or application, and to this
24 end the provisions of this Act are declared to be severable.

25

26 SECTION 40. GENERAL REPEALER. All laws and parts of laws in conflict
27 with this Act are hereby repealed.

28

29 SECTION 41. EMERGENCY CLAUSE. It is hereby found and determined by the
30 Eighty-first General Assembly, that the Constitution of the State of Arkansas
31 prohibits the appropriation of funds for more than a two (2) year period; that
32 the effectiveness of this Act on July 1, 1997 is essential to the operation of
33 the agency for which the appropriations in this Act are provided, and that in
34 the event of an extension of the Regular Session, the delay in the effective
35 date of this Act beyond July 1, 1997 could work irreparable harm upon the

1 proper administration and provision of essential governmental programs.
2 Therefore, an emergency is hereby declared to exist and this Act being
3 necessary for the immediate preservation of the public peace, health and
4 safety shall be in full force and effect from and after July 1, 1997.
