20	SECTION 1. Arkansas Code 22-9-403 is amended to read a	as follows:	
21	"22-9-403. Statutory liability as integral part of bond -		
22	Limitation of action.		
23	(a) The liability imposed by § $22-9-401$ on any bond furnished by		
24	a public works contractor shall be deemed an integral part of the bond,		
25	whether or not the liability is explicitly set out or assume	d therein.	
26	(b) $\underline{(1)}$ No action shall be brought on a bond after si	(6)	
27	months from the date final payment is made on the contract,	nor shall an	
28	action be brought outside the State of Arkansas.		
29	(2) However, with respect to public works contracts wh	nere final	
30	approval for payment is given by Arkansas State Building Ser	vices, all	
31	persons, firms, associations and corporations having valid c	laims	
32	against the bond may bring an action on the bond against the corporate		
33	surety, provided that no action shall be brought on the bond after		
34	twelve (12) months from the date on which the Arkansas State Building		
35	Services approves final payment on the state contract, nor shall any		
36	action be brought outside the State of Arkansas in accordance	a with

3	SECTION 2. All provisions of this act of a general and permanent
4	nature are amendatory to the Arkansas Code of 1987 Annotated and the
5	Arkansas Code Revision Commission shall incorporate the same in the
6	Code.
7	
8	SECTION 3. If any provision of this act or the application
9	thereof to any person or circumstance is held invalid, such invalidity
10	shall not affect other provisions or applications of the act which can
11	be given effect without the invalid provision or application, and to
12	this end the provisions of this act are declared to be severable.
13	
14	SECTION 4. All laws and parts of laws in conflict with this act
15	are hereby repealed.
