19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF	ARKANSAS:

21	SECTION 1. REGULAR SALARIES. There is hereby e	stablished for the					
22	Arkansas Game and Fish Commission for the 1997-99 bien	nium, the following					
23	maximum number of regular employees whose salaries sha	.1 be governed by the					
24	provisions of the Uniform Classification and Compensat	on Act (Arkansas Code					
25	$\mathring{\mbox{\it d}}\mathring{\mbox{\it d}}215201$ et seq.), or its successor, and all laws ame	ndatory thereto.					
26	Provided, however, that any position to which a specif	c maximum annual salary					
27	is set out herein in dollars, shall be exempt from the	provisions of said					
28	Uniform Classification and Compensation Act. All pers	ons occupying positions					
29	authorized herein are hereby governed by the provision	s of the Regular

35 SECTION 2. EXTRA HELP. There is hereby authorized, for the Arkansas

- 1 Game and Fish Commission for the 1997-99 biennium, the following maximum
- 2 number of part-time or temporary employees, to be known as "Extra Help",
- 3 payable from funds appropriated herein for such purposes: ninety (90)
- 4 temporary or part-time employees, when needed, at rates of pay not to exceed
- 5 those provided in the Uniform Classification and Compensation Act, or its
- 6 successor, or this act for the appropriate classification.

- 8 SECTION 3. APPROPRIATIONS. There is hereby appropriated, to the
- 9 Arkansas Game and Fish Commission, to be payable from the Game Protection
- 10 Fund, for personal services, operating expenses, acquisition, maintenance and
- 11 improvements of the Arkansas Game and Fish Commission for the biennial period
- 12 ending June 30, 1999, the following:

- 30 SECTION 4. SPECIAL LANGUAGE. Any savings in the amount appropriated in
- 31 Section 3 for Regular Salaries, Extra Help, or Personal Services Matching may
- 32 be transferred upon request of the Director of the State Game and Fish
- 33 Commission to Acquisition/Maintenance/Improvements. Upon approval of the
- 34 Chief Fiscal Officer of the State, and prior review by the Arkansas
- 35 Legislative Council, the Chief Fiscal Officer of the State and the Auditor of

- 1 the State shall transfer said savings to Acquisition/Maintenance/Improvements
- 2 and make it available for such purposes during the then current fiscal year.

- 4 SECTION 5. SPECIAL LANGUAGE TRANSFER PROVISION. Provided, that any
- 5 unexpended appropriation balance remaining on June 30, 1998 in the
- 6 appropriation authorized in Section 3 hereof, for Item (01) Regular Salaries;
- 7 Item (02) Extra Help; Item (03) Personal Services Matching; Item (04)
- 8 Maintenance and General Operation; and Item (06)
- 9 Acquisition/Maintenance/Improvements, shall be transferred by the Chief Fiscal
- 10 Officer and the Auditor of State to Item (06)
- 11 Acquisition/Maintenance/Improvements in Section 3 hereof, for the fiscal year
- 12 beginning July 1, 1998 and ending June 30, 1999 and made available for use in
- 13 said year.

14

- 15 SECTION 6. SPECIAL LANGUAGE. The Arkansas Game and Fish Commission is
- 16 hereby authorized to promulgate rules and regulations for the eligibility,
- 17 amounts and payment of rewards to individuals providing information leading to
- 18 the arrest of violators of Game and Fish Commission regulations. These
- 19 rewards shall be payable from the Game Protection Fund from the Commission's
- 20 Maintenance and General Operation appropriation as herein appropriated in
- 21 <u>Section 3, Item No. (04)(A).</u>

22

- 23 SECTION 7. SPECIAL LANGUAGE PROFESSIONAL CERTIFICATIONS. The
- 24 Arkansas Game and Fish Commission is hereby authorized, after prior review by
- 25 the Arkansas Legislative Council, to grant a six percent (6%) increase to any
- 26 regular salaried biologist possessing or acquiring professional certification
- 27 from the Wildlife Society or the American Fisheries Society during the 1997-99
- 28 biennium. This pay increase will be awarded beginning with the first bi-
- 29 weekly pay period following submission of documented proof of such
- 30 certification to the Commission Personnel Office, provided the biologist's
- 31 most recent performance evaluation results in a satisfactory rating.
- 32 Biologists not obtaining a satisfactory performance evaluation rating will be
- 33 granted the pay increase on their next eligibility date, provided their new
- 34 evaluation is satisfactory. New employees and probationary employees shall be
- 35 eligible for this pay increase after their probationary period expires,

- 1 provided the above requirements are met. Employees possessing or obtaining
- 2 the pay increase authorized herein shall not be eligible for a second
- 3 incentive increase upon obtaining a second professional certification from the
- 4 Wildlife Society or The American Fisheries Society.

- 6 SECTION 8. SPECIAL LANGUAGE. Arkansas Code 15-41-114 is hereby amended
- 7 to read as follows:
- 8 "15-41-114. Uniform allowance for uniformed employees.
- 9 A maximum of one hundred sixty dollars (\$100.00)(\$60.00) per month per
- 10 uniformed employee shall be payable to each uniformed employee employees only
- 11 for the purchase and maintenance of uniforms worn full time in the execution
- 12 of official duties of the Arkansas State Game and Fish Commission, and a
- 13 maximum of twenty five dollars (\$25.00) per month per uniformed employee shall
- 14 be payable to uniformed employees only for the purchase and maintenance of
- 15 uniforms worn at least sixteen (16) hours per week."

- 17 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
- 18 Assembly that any funds disbursed under the authority of the appropriations
- 19 contained in this Act shall be in compliance with the stated reasons for which
- 20 this Act was adopted, as evidenced by the Agency Requests, Executive
- 21 Recommendations and Legislative Recommendations contained in the budget
- 22 manuals prepared by the Department of Finance and Administration, letters, or
- 23 summarized oral testimony in the official minutes of the Arkansas Legislative
- 24 Council or Joint Budget Committee which relate to its passage and adoption.

- 26 SECTION 10. CODE. All provisions of this Act of a general and
- 27 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the
- 28 Arkansas Code Revision Commission shall incorporate the same in the Code.

29

- 30 SECTION 11. SEVERABILITY. If any provision of this Act or the
- 31 application thereof to any person or circumstance is held invalid, such
- 32 invalidity shall not affect other provisions or applications of the Act which
- 33 can be given effect without the invalid provision or application, and to this
- 34 end the provisions of this Act are declared to be severable.

SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict
 2 with this Act are hereby repealed.
         SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
 4
 5 Eighty-First General Assembly, that the Constitution of the State of Arkansas
 6 prohibits the appropriation of funds for more than a two (2) year period; that
 7 the effectiveness of this Act on July 1, 1997 is essential to the operation of
 8 the agency for which the appropriations in this Act are provided, and that in
 9 the event of an extension of the Regular Session, the delay in the effective
10 date of this Act beyond July 1, 1997 could work irreparable harm upon the
11 proper administration and provision of essential governmental programs.
12 Therefore, an emergency is hereby declared to exist and this Act being
13 necessary for the immediate preservation of the public peace, health and
14 safety shall be in full force and effect from and after July 1, 1997.
