9	"AN ACT TO AMEND ARKANSAS CODE 6 24-5-115 TO PROVIDE
10	MEMBERS OF THE ARKANSAS STATE HIGHWAY EMPLOYEES RETIREMENT
11	SYSTEM AN INCREASE IN THE MULTIPLIER AMOUNT FOR
12	CALCULATING RETIREMENT ANNUITIES; TO PROVIDE A BENEFIT
13	INCREASE FOR CERTAIN RETIRANTS AND BENEFICIARIES OF
14	RETIRANTS; TO DECLARE AN EMERGENCY; AND FOR OTHER
15	PURPOSES."

18	"INCREASING BENEFITS FOR THE RETIREES OF
19	THE ARKANSAS STATE HIGHWAY EMPLOYEES
20	RETIREMENT SYSTEM."

22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Arkansas Code Section $^{\circ}$ 24-5-115 is hereby amended to read
25	as follows:
26	"24-5-115. Benefits generally.
27	(a) (1) Members retired for the reasons set forth in $^{\mathring{6}\mathring{6}}24-5-112$ - 24-5-
28	114 shall be eligible for annual retirement benefits based on $\frac{1}{1}$ two and $\frac{1}{1}$ six one
29	$\frac{\text{hundredths percent (2.06\%)}}{\text{two and one tenth percent (2.1\%)}} \text{ of their average}$
30	compensation, as defined in $^{\mbox{\scriptsize 6}}245101\text{, limited to the amount upon which}$
31	contributions, including supplemental contributions under the provisions of
32	$^{\mbox{\scriptsize δ}}24\mbox{\scriptsize -5}\mbox{\scriptsize -108}$ (b) have been made, times the number of years of creditable service
33	in the Arkansas State Highway Employees Retirement System.
34	(2) Payments shall be made in equal monthly installments.
35	(b)(1) In the event a member has not completed payment of his service
36	contributions as provided for in $^{\circ}24-5-108$ (b) and is current in his or her

- 1 service contributions at the time of retirement, the Board of Turstees of the
- 2 Arkansas State Highway Employees Retirement System board is authorized to
- 3 deduct from each monthly annuity payment an amount equal to one-twelfth (1/12)
- 4 of the unpaid balance of such service contributions.
- 5 (2) The deductions shall continue until all service contributions
- 6 have been paid in full."

- 8 SECTION 2. (a) Effective July 1, 1997, the monthly retirement benefit
- 9 payable to the retirees and beneficiaries of the Arkansas State Highway
- 10 Employees $^{f ii}$ Retirement System who are entitled to receive an annuity for July
- 11 1997, shall be increased by two percent (2 %) above the annuity such retiree
- 12 or beneficiary received for June 1997.
- 13 (b) The increase in benefits as provided in this section shall be added
- 14 to the annuity for the purpose of computing the annual post-retirement
- 15 increase as provided in 8 24-5-119 (a) for the benefit re-determination July
- 16 1, 1997.

- 18 SECTION 3. All provisions of this act of a general and permanent nature
- 19 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 20 Revision Commission shall incorporate the same in the Code.

- 22 SECTION 4. If any provision of this act or the application thereof to
- 23 any person or circumstance is held invalid, such invalidity shall not affect
- 24 other provisions or applications of the act which can be given effect without
- 25 the invalid provision or application, and to this end the provisions of this
- 26 act are declared to be severable.

- 28 SECTION 5. All laws or parts of laws in conflict with this act are
- 29 hereby repealed, provided, none of the amendments contained in this Act are
- 30 intended to nor shall they be construed to amend or affect any of the state-
- 31 supported retirement system laws of this State, with the exception of the laws
- 32 pertaining to the Arkansas State Highway Employees $^{\blacksquare}$ Retirement System.

- 34 SECTION 6. EMERGENCY CLAUSE. It is hereby found and determined by the
- 35 Eighty-First General Assembly of the State of Arkansas that benefits provided
- 36 under the Arkansas State Highway Employees Retirement System are inadequate

1 and that an increase should be provided as soon as practicable in order to 2 avoid an undue hardship; in order for the Arkansas State Highway and 3 Transportation Department to continue to retain and recruit efficient and 4 skilled employees and by immediately increasing the multiplier amount for 5 retirement benefit purposes will greatly assist such retention and recruitment 6 efforts; and that benefits provided to retirants and beneficiaries under the 7 Arkansas State Highway Employees Retirement System are inadequate and that 8 an increase should be provided as soon as practicable in order to avoid an 9 undue hardship to many such retirants and beneficiaries. Therefore, an emergency is hereby declared to exist and this act being necessary for the 11 immediate preservation of the public peace, health and safety shall be in full 12 force and effect on and after July 1, 1997. 13 14 15 16 17 18 19 20 21 22 2.3 24 25 26 27 2.8 29 30 31 32 33 34 35
