9 "AN ACT TO REPEAL ARKANSAS CODE 15-22-505(3), WHICH
10 REQUIRES THE ARKANSAS SOIL AND WATER CONSERVATION
11 COMMISSION TO FURNISH TO EACH REGULAR SESSION OF THE
12 GENERAL ASSEMBLY A REPORT ON WATER DEVELOPMENT PROJECTS
13 AND WHICH IS MADE REDUNDANT BY SECTION 1 OF ACT 1123 OF
14 1995 (ARKANSAS CODE 25-1-105) REQUIRING ALL STATE BOARDS
15 AND COMMISSIONS TO FILE ANNUAL ACTIVITY REPORTS WITH THE
16 GENERAL ASSEMBLY."

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. The General Assembly finds:

26 (a) That Section 1(a)(2) of Act 1123 of 1995, codified as Arkansas Code
27 25-1-105, requires each state board or commission to file with the Governor
28 and Legislative Council an annual statement summarizing the board or
29 commission's activity during the previous year;

30 (b) The Arkansas Soil and Water Conservation Commission is subject to
31 the Act;

32 (c) Arkansas Code 15-22-505(3) requires the Commission to file reports
33 with the General Assembly during each regular session; and

34 (d) Act 1123 of 1995 renders Arkansas Code 15-22-505(3) duplicative and
35 burdensome.

1 SECTION 2. Arkansas Code 15-22-505(3) is hereby repealed.

2 ~~—— (3) To furnish to each regular session of the General Assembly a report~~
3 ~~containing a complete accounting of all sums received and expended on water~~
4 ~~development projects included in the Arkansas Water Plan, including economic~~
5 ~~justification, based upon need, estimated costs, and feasibility of any such~~
6 ~~project to be financed in whole or in part with state funds, and an outline of~~
7 ~~benefits accruing to the state as a whole;~~

9 SECTION 3. All provisions of this act of a general and permanent nature
10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
11 Revision Commission shall incorporate the same in the Code.

12

13 SECTION 4. If any provision of this act or the application thereof to
14 any person or circumstance is held invalid, such invalidity shall not affect
15 other provisions or applications of the act which can be given effect without
16 the invalid provision or application, and to this end the provisions of this
17 act are declared to be severable.

19 SECTION 5. All laws and parts of laws in conflict with this act are
20 hereby repealed.
