Arkansas Code Annotated 6 6-17-914 is amended to read as 29 follows: 30 "6-17-914. District budget. 31 (a) Each school district of the state shall prepare annually a budget 32 of expenditures and receipts which shall, no later than August 28 of each 33 year, be filed with the Department of Education. Each budget, approved by the 34 board of directors of the district in a legally held meeting and signed by the 35 president of the board and the ex officio financial secretary of the district, 36 shall contain such information and be prepared on such paper forms or

- 1 electronic format as prescribed by the State Board of Education.
- 2 (1) A school district that utilizes paper forms shall file the
- 3 budget with the department no later than August 28 of each year.
- 4 (2) A school district that utilizes an electronic format shall
- 5 file the budget with the department no later than September 15 of each year.
- 6 (b) Warrants or checks of the district issued after August 28 of a
- 7 fiscal year the date required by subsection (a) of this section shall be
- 8 invalid unless a budget has been filed as required by this subchapter. The ex
- 9 officio financial secretary of the district and his surety shall be liable for
- 10 any warrants or checks he countersigns after this date if a budget has not
- 11 been filed, and all grants and aids from the state for which the district may
- 12 be eligible shall be suspended until the requirements of this subchapter are
- 13 met.
- 14 (c) Budgets of the school districts of the state filed as required by
- 15 this section shall be reviewed by the Department of Education to determine if
- 16 the requirements of the statutes and the regulations of the State Board of
- 17 Education regarding the earmarking or use of school funds are being met. Upon
- 18 approval, copies of the approved budget shall be filed with the school
- 19 district, the county board of education, the county treasurer if serving as
- 20 school treasurer, and the Department of Education.
- 21 (d) The ex officio financial secretary of each school district shall
- 22 keep a record of the expenditures and receipts of the district in such manner
- 23 and on such forms as may be specified by the State Board of Education or the
- 24 School Audit Section of the Division of Legislative Audit of the Legislative
- 25 Joint Auditing Committee. When the Department of Education or the School Audit
- 26 Section of the Division of Legislative Audit of the Legislative Joint Auditing
- 27 Committee determines that the financial records of any school district are not
- 28 being properly kept or that the financial affairs of the district are not
- 29 being administered in accordance with state law or State Board of Education
- 30 regulations, grants and aids from the state to which the district may be
- 31 entitled shall be withheld until it can be determined that the fiscal records
- 32 of the district are in order or the financial affairs are being properly

- 34 (e)(1) The Department of Education may withhold state aid from any
- 35 school district that fails to file its budget or any other required report
- 36 with the department by the deadline established by statute or by regulation

- 3 (2) The department shall submit a list of all required reports,
- 4 with due dates, to each school district on or before July 1 of each year.
- 5 (f) The State Board of Education shall promulgate the necessary
- 6 regulations to fully implement the provisions of this section.
- 7 (g) The Treasurer of State may withhold the monthly distribution of
- 8 county aid provided for under $^{\circ}$ 19-5-602(b) from any county that fails to
- 9 provide the county board of education in a timely manner with information
- 10 necessary for submission to the Department of Education of the annual abstract
- 11 of assessment for each school district located wholly or in part in such
- 12 county."

- 14 SECTION 2. All provisions of this act of a general and permanent nature
- 15 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 16 Revision Commission shall incorporate the same in the Code.

- 18 SECTION 3. If any provision of this act or the application thereof to
- 19 any person or circumstance is held invalid, such invalidity shall not affect
- 20 other provisions or applications of the act which can be given effect without
- 21 the invalid provision or application, and to this end the provisions of this
- 22 act are declared to be severable.

- 24 SECTION 4. All laws and parts of laws in conflict with this act are
- 25 hereby repealed.
