20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKAN	SAS:

22	SECTION 1. Arkansas Code 27-70-207(a) is amended to	read as	
23	follows:		
24	"(a) All highway revenues transferred to the County Aid Fund		
25	under this subchapter shall be paid over by the Treasurer of	∍£ State	
26	<u>Treasurer</u> to the treasurers of the respective counties of t	chis state for	
27	credit to the county highway fund, there to be used for the	e maintenance,	
28	construction, and reconstruction of roads and bridges in the county		
29	highway system, provided, however, that no more than twenty percent		
30	(20%) of the revenues received by a county during any fiscal year may		
31	also be used for public transportation, and provided further	er, that a	
32	county may also use these funds to construct and maintain p	parking for	
33	county courthouses, county administration buildings, county health units		
34	and county parks. The Treasurer of State Treasurer shall, on or before		
35	the tenth day next following the last day of each calendar month, make		
36	distribution of the revenues on the following basis:		

- 1 (1) Thirty-one percent (31%) of the amount according to area,
- 2 with each county to receive the proportion that its area bears to the
- 3 area of the state;
- 4 (2) Seventeen and one-half percent (17.5%) of the amount
- 5 according to the amount of state motor vehicle license fees collected in
- 6 the calendar year next preceding any such distribution, as certified to
- 7 the Treasurer of State by the Director of the Department of Finance and
- 8 Administration, with each county to receive the proportion that the
- 9 total of fees collected from the county bears to the total of fees
- 10 collected in the state;
- 11 (3) Seventeen and one-half percent (17.5%) of the amount
- 12 according to population based upon the most recent federal decennial
- 13 census, with each county to receive the proportion that its population
- 14 bears to the population of the state;
- 15 (4) Thirteen and one-half percent (13.5%) of the amount according
- 16 to rural population based upon the most recent federal decennial census,
- 17 with each county to receive the proportion that its rural population
- 18 bears to the rural population of the state;
- 19 (5) Twenty and one-half percent (20.5%) of the amount shall be
- 20 divided equally among the seventy-five (75) counties."

- 22 SECTION 2. All provisions of this act of a general and permanent
- 23 nature are amendatory to the Arkansas Code of 1987 Annotated and the
- 24 Arkansas Code Revision Commission shall incorporate the same in the
- 25 Code.

- 27 SECTION 3. If any provision of this act or the application
- 28 thereof to any person or circumstance is held invalid, such invalidity
- 29 shall not affect other provisions or applications of the act which can
- 30 be given effect without the invalid provision or application, and to
- 31 this end the provisions of this act are declared to be severable.

- 33 SECTION 4. All laws and parts of laws in conflict with this act
- 34 are hereby repealed.
