2 SECTION 3. If any provision of this act or the application thereof to 3 any person or circumstance is held invalid, such invalidity shall not affect 4 other provisions or applications of the act which can be given effect without 5 the invalid provision or application, and to this end the provisions of this 6 act are declared to be severable. 8 SECTION 4. All laws and parts of laws in conflict with this act are 9 hereby repealed. 10 SECTION 5. EMERGENCY. It is found and determined by the General 11 12 Assembly of the State of Arkansas that the caseload, and thusly, the workload 13 of the Magnolia Municipal Court has increased and the salary cap for the 14 Magnolia Municipal Court Clerk and Deputy Clerk must be raised in order to 15 retain efficient court personnel, and this act so provides and should 16 therefore be given immediate effect. Therefore an emergency is declared to 17 exist and this act being immediately necessary for the preservation of the 18 public peace, health and safety shall become effective on the date of its 19 approval by the Governor. If the bill is neither approved nor vetoed by the 20 Governor, it shall become effective on the expiration of the period of time 21 during which the Governor may veto the bill.
