24 SECTION 2. It is the purpose of this act to protect the health, safe	
and welfare of the public by providing for the certification and regulation	,

30 SECTION 3. As used in this act:	
31 (1) "Board" means the Arkansas Board of Health Education;	
32 (2) "Degree" means a baccalaureate or post-baccalaureate degree from	<u>a</u>

<pre>34 conferred; 35 (3) "Certified Health Education Specialist" or "CHES" means a person</pre>

- 1 and concurrently certified under this act to engage in the practice of health
- 2 education in this state;
- 3 (4) "Certified Professional Health Educator" or "CPHE" means a person
- 4 certified under this act to engage in the practice of health education in this

- 6 (5) "Provisionally Certified Health Educator" means a person
- 7 provisionally certified under this act to engage in the practice of health
- 8 education in this state;
- 9 (6) "Practice of Health Education" means the integration and
- 10 application of principles derived from the sciences of biology and physiology,
- 11 psychology, sociology, and other behavioral sciences and education to enable
- 12 people, as individuals and as members of social structures, to voluntarily
- 13 make decisions, modify behaviors, and change social conditions in ways which
- 14 are health enhancing in any of the following ways:
- 15 (A) Assessing individual and community needs for health
- 16 education;
- 17 (B) Planning effective health education programs;
- 18 (C) Implementing health education programs;
- 19 (D) Evaluating the effectiveness of health education programs;
- 20 (E) Coordinating health education services;
- 21 (F) Providing resources to health education programs and
- 22 practices; and
- 23 (G) Communicating health and health education needs, concerns,
- 24 and resources; and
- 25 (7) "Health Educator" means a person engaged in the practice of health
- 26 education.

- 28 SECTION 4. (a) This article shall not be construed to limit the
- 29 professional pursuits of:
- 30 (1) A health educator serving in the armed forces or the Public
- 31 Health Service of the United States or employed by the Veterans Administration
- 32 provided that the persons practice of health education is related to the
- 33 persons service or employment;
- 34 (2) A licensed physician, pharmacist, nurse, social worker,
- 35 psychologist, psychological examiner, licensed professional counselor,
- 36 dietician, dental hygienist, physical therapist, or occupational therapist if

- 1 the persons practice of health education is incidental to the practice of his
- 2 or her profession, providing that such persons do not hold themselves out
- 3 under the title of certified health education specialist, certified
- 4 professional health educator, or health educator, unless so certified;
- 5 (3) Any person who has received a doctoral degree from an
- 6 accredited U. S. college or university in or with a concentration in health
- 7 education;
- 8 (4) A nonresident health educator practicing health education in
- 9 this state if:
- 10 (A) the health education practice is limited to no more
- 11 than one hundred eighty (180) consecutive working days; and
- 12 (B)(1) the health educator is certified under the laws of
- 13 another state which has certification requirements at least as stringent as
- 14 the requirements of this state, as determined by the Board; or
- 15 (2) the health educator has met qualifications as
- 16 specified in this act for the practice of health education;
- 17 (5) A teacher of health education in an elementary or secondary
- 18 school who meets the certification requirements as set forth by the Arkansas
- 19 Department of Education;
- 20 (6) A health educator who engages in the practice of health
- 21 education in a hospital licensed by the State of Arkansas;
- 22 (7) Any occupational safety and health professional, such as an
- 23 industrial hygienist, providing that such persons do not hold themselves out
- 24 under the title of certified health education specialist, certified
- 25 professional health educator, or health educator, unless so certified; and
- 26 (8) Employees who work under the guidance of a licensed
- 27 physician, providing that such persons do not hold themselves out under the
- 28 title of certified health education specialist, certified professional health
- 29 educator, or health educator, unless so certified.
- 30 (b) Students may engage in the practice of health education provided
- 31 that such practice is performed under the supervision of a Certified Health
- 32 Education Specialist or a Certified Professional Health Educator and is part
- 33 of the academic requirements leading to a degree in or with a concentration in
- 34 health education.
- 35 (c) Volunteers, staff, or agents working under the direction of a
- 36 charitable organization registered with the Office of Attorney General or a

- 1 non-profit corporation may conduct health education related activities,
- 2 provided that such persons do not hold themselves out under the title of
- 3 certified health education specialist, certified professional health educator,
- 4 or health educator, unless so certified.
- 5 (d) Employees of nursing homes may conduct health education related
- 6 activities, provided that such persons do not hold themselves out under the
- 7 title of certified health education specialist, certified professional health
- 8 educator, or health educator unless so certified.
- 9 (e) Community volunteers may conduct health education related
- 10 activities, provided that such persons do not hold themselves out under the
- 11 title of certified health education specialist, certified professional health
- 12 educator, or health educator unless so certified.
- 13 (f) When invited by school officials, parents or volunteers may
- 14 conduct health education related activities in private or public school
- 15 classrooms or assemblies, provided that such persons do not hold themselves
- 16 out under the title of certified health education specialist, certified
- 17 professional health educator or health educator unless so certified.
- 18 (g) This act is not intended to apply to foundations, state agencies,
- 19 any other groups, and other professional boards and associations and their
- 20 continuing education efforts.

- 22 SECTION 5. (a) There is created the Arkansas Board of Health
- 23 Education, which shall consist of seven (7) persons, all of whom are Arkansas
- 24 residents, with the following qualifications:
- 25 (1) five (5) members who are Certified Health Education
- 26 Specialists or Certified Professional Health Educators;
- 27 (2) two (2) members who are representatives of the public at
- 28 large.
- 29 (b) The members of the board shall be appointed by the Governor,
- 30 subject to confirmation by the Senate.
- 31 (c)(1) The Governor shall designate the terms of the initial appointees
- 32 so that three (3) members, including two (2) health educators and one (1)
- 33 member who represents the public at large shall serve three (3) year terms;
- 34 two (2) members, including one (1) health educator and one (1) member who
- 35 represents the public at large shall serve two (2) year terms; and two (2)
- 36 members who represent health educators shall serve one (1) year terms.

- 1 (2) Successor members shall serve three (3) year terms, except
- 2 that a person appointed to fill a vacancy resulting in an unexpired term shall
- 3 only serve for the remainder of that unexpired term. Any vacancy on the board
- 4 shall be filled by the Governor in the same manner as other appointments. No
- 5 member shall serve more than two (2) consecutive terms.
- (d)(1) Initial members, who are representatives of the health education
- 7 profession, shall be selected from a list of persons, who have been practicing
- 8 health education for at least three (3) years, submitted to the Governor by
- 9 the Division of Health Education and Promotion of the Department of Health in
- 10 conjunction with the National Commission on Health Education Credentialing.
- 11 (2) Successor members, who are representatives of the health
- 12 education profession, shall be selected from a list of Certified Health
- 13 Education Specialists or Certified Professional Health Educators submitted to
- 14 the Governor by the Arkansas Board of Health Education. Each of these board
- 15 members shall have been practicing health education for at least three (3)
- 16 years preceding their appointment and be listed as a person certified under
- 17 this act.
- 18 (e) Upon recommendation of the board, made after notice and hearing,
- 19 the Governor may remove any member of the board for incompetence, neglect of
- 20 duty or malfeasance in office.
- 21
- 22 SECTION 6. (a) The Governor shall call the first board meeting within
- 23 thirty (30) days after its members are first appointed for the purpose of
- 24 organization. The board shall elect at its first regularly scheduled meeting
- 25 of each calendar year a chairperson and vice-chairperson. The board shall
- 26 meet as frequently as it deems necessary, at such times and places as the
- 27 board designates. Additional meetings may be held upon call of the
- 28 chairperson or upon written request of four (4) members of the board.
- 29 (b) A quorum of the Board shall consist of four (4) members.
- 30 (c) The members shall not be entitled to compensation for their service
- 31 but may receive expense reimbursement in accordance with A.C.A. 8 25-16-902.
- 32 All reimbursements for expenses authorized by this act shall be paid from the
- 33 Health Education Practice Certification Fund.
- 34 (d) All proceedings of the board shall be conducted in accordance with
- 35 the Arkansas Administrative Procedure Act, A.C.A. 88 25-15-201, et seq.

- 1 SECTION 7. (a)(1) The secretary of the board shall receive and account
- 2 for all money derived under the provisions of this act, and shall deposit the
- 3 same weekly into financial institutions other than the State Treasury.
- 4 (2) These monies shall be known as the Health Education Practice
- 5 Certification Fund.
- 6 (b) There shall be audits of the Fund as required by law.
- 7 (c) The secretary of the board shall give a surety bond for the
- 8 faithful performance of his or her duties in the sum of ten thousand dollars
- 9 (\$10,000) or an amount recommended by the State Auditor. The premium for this
- 10 bond shall be paid out of the Health Education Practice Certification Fund.
- 11 (d) The board may make expenditures from the Health Education Practice
- 12 Certification Fund for any purpose which is reasonable and necessary to carry
- 13 out the provisions of this act.

- 15 SECTION 8. The board shall have the following powers and duties:
- 16 (1) establish an examination requirement if deemed necessary;
- 17 (2) certify and renew the certification of qualified applicants;
- 18 (3) establish certification reciprocity agreements with other states;
- 19 (4) establish and collect fees relating to examination, certification,
- 20 provisional certification, certification renewal and other reasonable services
- 21 as defined by the board;
- 22 (5) promulgate rules and regulations necessary to implement this act;
- 23 (6) compile an annual report to be filed with the Governor and the
- 24 Legislative Council by September 1 of each year;
- 25 (7) define unprofessional conduct by publishing Standards of
- 26 Professional Responsibility for Health Educators and publish such standards
- 27 for practice within twelve (12) months after the first board meeting;
- 28 (8) conduct disciplinary proceedings as provided for in this act; and
- 29 (9) establish continuing education requirements consistent with those
- 30 of the National Commission for Health Education credentialing as a means to
- 31 maintain professional competency.

- 33 SECTION 9. (a) The board shall issue a state concurrent certification
- 34 to a Certified Health Education Specialist who:
- 35 (1) files an application with the board;
- 36 (2) provides evidence of current certification as a Certified

- 1 Health Education Specialist from the National Commission for Health Education
- 2 Credentialing; and
- 3 (3) passes an examination if required by the board.
- 4 (b) The state concurrent certification of a Certified Health Education
- 5 Specialist shall be effective upon issuance by the board and shall be valid
- 6 for one (1) year after the date of issuance.

- 8 SECTION 10. For one (1) year after the effective date of this act, the
- 9 board shall issue certification as a Certified Professional Health Educator to
- 10 any person who:
- 11 (1) files an application with the board;
- 12 (2) provides evidence of having earned a degree from a U. S. college or
- 13 university that was accredited at the time the degree was conferred;
- 14 (3) provides evidence of employment in the practice of health education
- 15 for at least three (3) of the last ten (10) years preceding the effective date
- 16 of this act; and
- 17 (4) passes an examination within two (2) years.

18

- 19 SECTION 11. (a) Provisional certification to practice as a health
- 20 educator may be issued by the board upon the filing of an application and
- 21 submission of evidence of successful completion of educational requirements as
- 22 determined by the board.
- 23 (b) A provisional certification shall expire eighteen (18) months from
- 24 the date of issuance. Provisional certification may be renewed once upon
- 25 submission to the board of a satisfactory explanation for the applicants
- 26 failure to become certified within the original eighteen (18) month period.
- 27 (c) A provisional certification shall permit the holder to practice
- 28 only under the supervision of a Certified Health Education Specialist or
- 29 Certified Professional Health Educator.

30

- 31 SECTION 12. Reciprocity shall be provided for certified health
- 32 educators from other states provided that the standards for certification in
- 33 that state are not less than those provided for in this act as determined by
- 34 the board.

35

36 SECTION 13. The following acts shall constitute violations of this act:

- 1 (1) Representing oneself to be a Certified Health Education Specialist
- 2 or a Certified Professional Health Educator or use the letters CHES or CPHE or
- 3 any facsimile thereof, or under such title or descriptions offering to give or
- 4 giving health education services to individuals, groups, agencies or
- 5 corporations unless certified under this act;
- 6 (2) Attempting to engage in the practice of health education without
- 7 having first been certified or otherwise permitted to engage in health
- 8 education activities under the provisions of this act;
- 9 (3) Obtaining or attempting to obtain certification or certification
- 10 renewal by bribery or fraudulent representation; and
- 11 (4) Knowingly making a false statement on any form promulgated by the
- 12 board in accordance with this act.

- 14 SECTION 14. The board may refuse to issue or renew a certification or
- 15 may revoke or suspend a certification issued under this act for any of the
- 16 following:
- 17 (1) violating a provision of this act;
- 18 (2) engaging in unprofessional conduct or gross incompetence as defined
- 19 by the regulations of the board;
- 20 (3) violating the Standards of Professional Responsibility for Health
- 21 Educators;
- 22 (4) being found guilty or pleading guilty or nolo contendere to a
- 23 criminal offense in this or any other state when such offense is a felony in
- 24 this state;
- 25 (5) being found guilty of or pleading guilty or nolo contendere to a
- 26 felony in a federal court.

27

- 28 SECTION 15. Any person who violates this act shall be deemed guilty of
- 29 a Class A misdemeanor.

30

- 31 SECTION 16. All provisions of this act of a general and permanent
- 32 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
- 33 Code Revision Commission shall incorporate the same in the Code.

- 35 SECTION 17. If any provision of this act or the application thereof to
- 36 any person or circumstance is held invalid, such invalidity shall not affect

1 other provisions or applications of the act which can be given effect without
 2 the invalid provision or application, and to this end the provisions of this
 3 act are declared to be severable.

         SECTION 18. All laws and parts of laws in conflict with this act are
 6 hereby repealed.
