| 22 | BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:               |

| 24 | SECTION 1. Arkansas Code 12-10-323(a) is amended by inserting the             |
| 25 | additional subsection to read as follows:                                     |
| 26 | "(a) Revenue generated as authorized in $^{66}$ 12-10-318 - 12-10-321 may be  |
| 27 | expended only for the following purposes:                                     |
| 28 | (1) The engineering, installation, and recurring costs necessary              |
| 29 | to implement, operate, and maintain a 911 telephone system;                   |
| 30 | (2) The costs necessary for forwarding and transfer capabilities              |
| 31 | of calls from the 911 public safety communication center to dispatch centers  |
| 32 | or to other 911 public safety communication centers;                          |
| 33 | (3) Engineering, construction, lease or purchase costs to lease,              |
| 34 | purchase, build, remodel, or refurbish a 911 public safety communication      |
| 35 | center and for necessary emergency and uninterruptable power supplies for the |
| 36 | center;   |

- 1 (4) Personnel costs in the amount of seventy-five percent (75%) of
- 2 the salary and benefits of each position charged with supervision and
- 3 operation of the 911 public safety communication center and system;
- 4 (5) Purchase, lease, operation, and maintenance of consoles,
- 5 telephone, and communications equipment owned or operated by the political
- 6 subdivisions and physically located within and for the use of the 911 public
- 7 safety communication center and radio or microwave towers and equipment with
- 8 lines which terminate in the center; and
- 9 (6) Purchase, lease, operation, and maintenance of computers, data
- 10 processing equipment, associated equipment, and leased audio or data lines
- 11 assigned to and operated by the 911 public safety communication center for the
- 12 purposes of coordinating, forwarding of calls, dispatch, or recordkeeping of
- 13 public safety and private safety agencies, for which the 911 public safety
- 14 communication center is the public safety answering point and to provide
- 15 information assistance to those agencies  $\pm i$  and
- 16 (7) Supplies, equipment, vehicle and vehicle maintenance,
- 17 maintenance and operating costs, and capital outlay deemed necessary by the
- 18 Quorum Court of the particular county in determining the annual appropriation
- 19 to the activity designated to provide the central administration, operation,
- 20 and supervision of the 911 county-wide system."

- 22 SECTION 2. All provisions of this act of a general and permanent nature
- 23 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 24 Revision Commission shall incorporate the same in the Code.

- 26 SECTION 3. If any provision of this act or the application thereof to
- 27 any person or circumstance is held invalid, such invalidity shall not affect
- 28 other provisions or applications of the act which can be given effect without
- 29 the invalid provision or application, and to this end the provisions of this
- 30 act are declared to be severable.

- 32 SECTION 4. All laws and parts of laws in conflict with this act are
- 33 hereby repealed.

- 35 SECTION 5. EMERGENCY: It is hereby found and determined by the General
- 36 Assembly that Arkansas Code 12-10-323, based upon Act 683 of the 1985

1 Legislative Session, which established authorized expenditures of revenues 2 generated to specifically support the 911 Public Safety program does not take 3 into consideration the additional costs which are necessary for the operation 4 and updating of the system to specifically include the broad range of 5 supplies, other services and charges, and capital outlay. Further, the proper 6 functioning of the 911 Public Safety Program requires that authority be extended to include all of the other remaining categories of expenditures as 8 authorized uses of the revenues entailed. Therefore, an emergency is declared 9 to exist and this act being immediately necessary for the preservation of the 10 public peace, health and safety shall become effective on the date of its 11 approval by the Governor. If the bill is neither approved nor vetoed by the 12 Governor, it shall become effective on the expiration of the period of time 13 during which the Governor may veto the bill.
