19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 17-19-402 is amended to read as follows:

22 ~~§~~17-19-402. Establishment of program - Schedule of fees.

23 (a)~~(1)~~ ~~The Arkansas Professional Bail Association shall~~ Professional
24 Bail Bond Company and Professional Bail Bondsman Licensing Board shall on an
25 annual basis solicit proposals from interested parties, and upon review of the
26 proposals from all applicants, designate an entity or entities to establish an
27 education program for professional bail bondsmen which will enable bail
28 bondsmen to meet the education and continuing education requirements of § 17-
29 19-212 and § 17-19-401 et seq.

30 ~~————— (2) Provided, the education program and the courses and training~~
31 ~~offered shall be subject to the approval of the Professional Bail Bond Company~~
32 ~~and Professional Bail Bondsman Licensing Board.~~

33 (b)(1) The ~~association~~ Professional Bail Bond Company and Professional
34 Bail Bondsman Licensing Board or its designee shall establish a schedule of
35 fees to be paid by each bail bondsman for the educational training.

4 SECTION 2. Arkansas Code 17-19-403 is repealed.

6 ~~The Arkansas Professional Bail Association shall annually pay to the~~
7 ~~board a fee of one hundred dollars (\$100) for review and approval of the~~
8 ~~education program and the fee schedule established by the association for the~~
9 ~~education and continuing education of professional bail bondsmen.~~

11 SECTION 3. All provisions of this act of a general and permanent nature
12 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
13 Revision Commission shall incorporate the same in the Code.

15 SECTION 4. If any provision of this act or the application thereof to
16 any person or circumstance is held invalid, such invalidity shall not affect
17 other provisions or applications of the act which can be given effect without
18 the invalid provision or application, and to this end the provisions of this
19 act are declared to be severable.

21 SECTION 5. All laws and parts of laws in conflict with this act are
22 hereby repealed.
