1	SECTION 1. (a) Each insurance agent of an insurance company that		
2	provides insurance coverage for property which is within the service area of		
3	any rural fire department is requested to cooperate with the rural fire		
4	departments by confirming, upon request of the rural fire department, the		
5	names and addresses of their insureds who claim to be members of the rural		
6	fire department.		
7	(b) The State Insurance Commissioner is requested to provide a copy of		
8	this act to each insurance company that provides fire insurance coverage in		
9	Arkansas.

11	SECTION 2. All provisions of this act of a general and permanent nature		
12	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code		
13	Revision Commission shall incorporate the same in the Code.		
14			
15	SECTION 3. If any provision of this act or the application thereof to		
16	any person or circumstance is held invalid, such invalidity shall not affect		
17	other provisions or applications of the act which can be given effect without		
18	the invalid provision or application, and to this end the provisions of this		
19	act are declared to be severable.

21	SECTION 4. All laws and parts of laws in conflict with this act are		
22	hereby repealed.
