9 "AN ACT TO MAKE AN APPROPRIATION FOR OPERATING EXPENSES
10 FOR THE UNIVERSITY OF ARKANSAS WHICH SHALL BE SUPPLEMENTAL
11 AND IN ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 1161 OF
12 1995, TO THE UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES
13 FOR EQUIPMENT; AND FOR OTHER PURPOSES."

16 "AN ACT FOR THE UNIVERSITY OF ARKANSAS
17 SUPPLEMENTAL APPROPRIATION."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
22 University of Arkansas, to be payable from the University of Arkansas Fund,
23 for operating expenses of the University of Arkansas which shall be
24 supplemental and in addition to those funds appropriated in Section 3
25 of Act 1161 of 1995, the following:

1 SECTION 2. FUNDING TRANSFER. Immediately upon the effective date of
2 this Act, the Chief Fiscal Officer of the State shall transfer on his books
3 and those of the State Treasurer the sum of ninety thousand two hundred sixty
4 two dollars (\$90,262) from the General Revenue Allotment Reserve Fund to the
5 University of Arkansas Fund to provide funds for the appropriation provided
6 herein.

7
8 SECTION 3. *Effective July 1, 1997, there is hereby appropriated, to the*
9 *University of Arkansas for Medical Sciences, to be payable from the General*
10 *Improvement Fund or its successor fund or fund account, for hospital and*
11 *teaching equipment, the sum of\$1,000,000.*

12
13 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
14 authorized by this Act shall be limited to the appropriation for such agency
15 and funds made available by law for the support of such appropriations; and
16 the restrictions of the State Purchasing Law, the General Accounting and
17 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
18 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions
19 Act, or their successors, and other fiscal control laws of this State, where
20 applicable, and regulations promulgated by the Department of Finance and
21 Administration, as authorized by law, shall be strictly complied with in
22 disbursement of said funds.

23
24 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General
25 Assembly that any funds disbursed under the authority of the appropriations
26 contained in this Act shall be in compliance with the stated reasons for which
27 this Act was adopted, as evidenced by the Agency Requests, Executive
28 Recommendations and Legislative Recommendations contained in the budget
29 manuals prepared by the Department of Finance and Administration, letters, or
30 summarized oral testimony in the official minutes of the Arkansas Legislative
31 Council or Joint Budget Committee which relate to its passage and adoption.

32
33 SECTION 6. CODE. All provisions of this Act of a general and permanent
34 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
35 Code Revision Commission shall incorporate the same in the Code.

SECTION 7. SEVERABILITY. If any provision of this Act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are declared to be severable.

SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict with this Act are hereby repealed.

SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the Eighty-First General Assembly that funds provided by the General Assembly for the operations of the University of Arkansas are, due to unforeseen circumstances, insufficient for the University of Arkansas to continue to provide essential governmental services; that the provisions of this act will provide the necessary monies for the University of Arkansas to continue such services; and that a delay in the effective date of this Act could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval.
