19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21	SECTION 1. Arkansas Code $^{\circ}$ 27-72-310 is amended to read as follows:	
22	"27-72-310. Contracts for work to be performed.

31	(b) The county judge of any county is authorized to submit bids for	}
32	work to be performed on state aid roads under the provisions of this	
33	subchapter, to be performed by county forces so long as such bids are in	
34	accordance with procedures prescribed in \$27-67-206, and the aggregate co	st
35	thereof does not exceed seventy-five thousand dollars (\$75,000)."

SECTION 2. All provisions of this act of general and permanent nature 2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 3 Revision Commission shall incorporate the same in the Code. SECTION 3. If any provisions of this act or the application thereof to 6 any person or circumstance is held invalid, the invalidity shall not affect 7 other provisions or applications of the act which can be given effect without 8 the invalid provisions or application, and to this end the provisions of this 9 act are declared to be severable. SECTION 4. All laws and parts of laws in conflict with this act are 12 hereby repealed.
