19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code ~~§~~ 27-72-310 is amended to read as follows:

22 "27-72-310. Contracts for work to be performed.

23 ~~_____ (a) All proposals covering work to be performed on state aid roads in~~
24 ~~each county in this state shall be under contract let and approved by the~~
25 ~~State Highway Commission, upon request from the county judge of the county and~~
26 ~~in accordance with the procedures prescribed in ~~§~~ 27-67-206, as amended, and~~
27 ~~other laws of this state pertaining to contracts for the construction of state~~
28 ~~highways, which laws shall be equally applicable to all contracts let by the~~
29 ~~State Highway Commission for the construction of state aid roads under this~~
30 ~~subchapter.~~

31 ~~_____ (b) The county judge of any county is authorized to submit bids for~~
32 ~~work to be performed on state aid roads under the provisions of this~~
33 ~~subchapter, to be performed by county forces so long as such bids are in~~
34 ~~accordance with procedures prescribed in ~~§~~ 27-67-206, and the aggregate cost~~
35 ~~thereof does not exceed seventy-five thousand dollars (\$75,000)."~~

1 SECTION 2. All provisions of this act of general and permanent nature
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
3 Revision Commission shall incorporate the same in the Code.

5 SECTION 3. If any provisions of this act or the application thereof to
6 any person or circumstance is held invalid, the invalidity shall not affect
7 other provisions or applications of the act which can be given effect without
8 the invalid provisions or application, and to this end the provisions of this
9 act are declared to be severable.

11 SECTION 4. All laws and parts of laws in conflict with this act are
12 hereby repealed.
