10 "AN ACT TO PRESCRIBE THE MAXIMUM SALARY AND EXPENSE
11 ALLOWANCE OF THE DEPUTY PROSECUTING ATTORNEY FOR CLAY
12 COUNTY; AND FOR OTHER PURPOSES."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Section 1 of uncodified Act 751 of 1983 as amended is
22 amended to read as follows:

23 "Section 1. The prosecuting attorney of the Second Circuit-Chancery
24 Court Circuit may appoint one (1) or more deputy prosecuting attorneys for
25 Clay County at a combined salary not to exceed ~~twenty-five thousand dollars~~
26 ~~(\$25,000)~~ thirty thousand dollars (\$30,000) per annum plus a combined
27 contingent expense allowance not to exceed ~~five thousand five hundred dollars~~
28 ~~(\$5,500)~~ nine thousand five hundred dollars (\$9,500) per annum."
29

30 SECTION 2. All provisions of this act of a general and permanent nature
31 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
32 Revision Commission shall incorporate the same in the Code.
33

34 SECTION 3. If any provision of this act or the application thereof to
35 any person or circumstance is held invalid, such invalidity shall not affect
36 other provisions or applications of the act which can be given effect without

1 the invalid provision or application, and to this end the provisions of this
2 act are declared to be severable.

3

4 SECTION 4. All laws and parts of laws in conflict with this act are
5 hereby repealed.

6

7 SECTION 5. EMERGENCY. It is hereby found and determined by the General
8 Assembly that the present law establishing a maximum salary and expense
9 allowance for the deputy prosecuting attorney for Clay County is inadequate;
10 that this act increases the salary maximum and expense allowance to a more
11 reasonable level and will allow the county more flexibility in compensating
12 its deputy prosecuting attorney; and that this act should go into effect
13 immediately in order to grant the increased authority to the county as soon as
14 possible. Therefore an emergency is declared to exist and this act being
15 immediately necessary for the preservation of the public peace, health and
16 safety shall become effective on the date of its approval by the Governor. If
17 the bill is neither approved nor vetoed by the Governor, it shall become
18 effective on the expiration of the period of time during which the Governor
19 may veto the bill. If the bill is vetoed by the Governor and the veto is
20 overridden, it shall become effective on the date the last house overrides the
21 veto.
