Conduct that is prohibited or 7 restricted on election day shall be subject to the same prohibitions and 8 restrictions on the days on which early voting is conducted. 9 10 SECTION 2. All provisions of this act of a general and permanent 11 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 12 Code Revision Commission shall incorporate the same in the Code. 13 14 SECTION 3. If any provision of this act or the application thereof to 15 any person or circumstance is held invalid, such invalidity shall not affect 16 other provisions or applications of the act which can be given effect without 17 the invalid provision or application, and to this end the provisions of this 18 act are declared to be severable. 19 SECTION 4.
