9 "AN ACT TO PROHIBIT THE SALE OF REFRIGERATED ALCOHOLIC
10 BEVERAGES FOR OFF-PREMISES CONSUMPTION WITHIN TEN (10)
11 FEET OF THE CASH REGISTER IN RETAIL ESTABLISHMENTS ALSO
12 SELLING MOTOR FUELS; AND FOR OTHER PURPOSES."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTIONS 1. On and after the effective date of this act, no beer, wine,
23 wine coolers, or other alcoholic beverages intended for off-premises
24 consumption in Arkansas shall be sold or displayed for sale in a cooled, iced,
25 chilled, or refrigerated condition or in any promotional container within ten
26 (10) feet of the cash register or within ten (10) feet of where customers pay
27 for or otherwise conclude sales transactions for purchases within a retail
28 business establishment which also sells and dispenses motor fuels, nor shall
29 it be sold or displayed for sale, in like containers, within ten (10) feet of
30 any pumps used for the dispensing motor fuels at a retail business
31 establishment also selling and dispensing motor fuels.

33 SECTION 2. The Arkansas Alcoholic Beverage Control Board is authorized
34 and shall promulgate any necessary rules and regulations to implement and
35 enforce the provisions of this act.

1 SECTION 3. All provisions of this act of general and permanent nature
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
3 Revision Commission shall incorporate the same in the Code.

4

5 SECTION 4. If any provisions of this act or the application thereof to
6 any person or circumstance is held invalid, the invalidity shall not affect
7 other provisions or applications of the act which can be given effect without
8 the invalid provisions or application, and to this end the provisions of this
9 act are declared to be severable.

10

11 SECTION 5. All laws and parts of laws in conflict with this act are
12 hereby repealed.
