22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24	SECTION 1. Arkansas Code Annotated 6 6-82-310 is amended to read as	
25	follows:	
26	"6-82-310. Use of scholarship.	
27	(a) No student may utilize these funds for educational purposes beyon	nd
28	the baccalaureate degree.	
29	(b)(1) There shall be an exception to the requirement of subsection (<u>(a)</u>
30	of this section for any student who receives a baccalaureate degree in three	<u>=</u>
31	(3) years or less.	
32	(2) Such student may receive an award of the scholarship for a	
33	fourth academic year to be used as a full-time student enrolled in a	
34	postgraduate program at an approved institution.

36	SECTION 2. Arkansas Code Annotated $^{\circ}$ 6-82-302(1) is amended to read a	ıs

- 2 "(1) Approved institution means a public or private college or
- 3 university:
- 4 (A) Dedicated to educational purposes, located in Arkansas, or
- 5 located out of state and educating Arkansas residents in dentistry, optometry,
- 6 veterinary medicine, podiatry, chiropractic, or osteopathy under agreement
- 7 with the Board of Control for Southern Regional Education, accredited by an
- 8 accrediting agency certified and recognized by the United States Department of
- 9 Education or the Division of Agency Evaluation and Institutional
- 10 Accreditation, or a school giving satisfactory assurance that it has the
- 11 potential for accreditation and is making progress which, if continued, will
- 12 result in its achieving accreditation;
- 13 (B) Which does not discriminate in the admission of students on
- 14 the basis of race, color, religion, sex, or national origin; and
- 15 (C) Which subscribes to the principle of academic freedom;"

- 17 SECTION 3. All provisions of this act of a general and permanent nature
- 18 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 19 Revision Commission shall incorporate the same in the Code.

- 21 SECTION 4. If any provision of this act or the application thereof to
- 22 any person or circumstance is held invalid, such invalidity shall not affect
- 23 other provisions or applications of the act which can be given effect without
- 24 the invalid provision or application, and to this end the provisions of this
- 25 act are declared to be severable.

- 27 SECTION 5. All laws and parts of laws in conflict with this act are
- 28 hereby repealed.

- 30 SECTION 6. EMERGENCY. It is found and determined by the General
- 31 Assembly that there are some students who qualify for a Governor's Scholarship
- 32 and receive an undergraduate degree in three (3) years or less and that
- 33 allowing these students to use the Governor's Scholarship for a fourth year in
- 34 a postgraduate program would provide an incentive to other students to strive
- 35 toward receiving a bachelors degree in less than four (4) years and that the
- 36 immediate effectiveness of this act is essential to the efficient

1 administration of the Governor's Scholarship Program. Therefore, an emergency 2 is declared to exist and this act being immediately necessary for the 3 preservation of the public peace, health and safety shall become effective on 4 the date of its approval by the Governor. If the bill is neither approved nor 5 vetoed by the Governor, it shall become effective on the expiration of the 6 period of time during which the Governor may veto the bill. If the bill is 7 vetoed by the Governor and the veto is overridden, it shall become effective 8 on the date the last house overrides the veto. /s/Young 2.8
