(b)(1) Professional bail bond companies shall be included on the list 2 in the order in which they were initially registered with the circuit clerk 3 pursuant to this chapter. (2) The order of the company names shall not change from year to 5 year. (3) The agents' names will be listed under the professional bail 7 bond company with whom they are licensed. No agents names will appear on the 8 list. (c) The list prepared by the circuit clerk and approved by the circuit 10 court shall be prepared pursuant to the following specifications: 11 (1) The list shall contain three (3) columns which shall be 12 headed as follows: (A) Bail bond company; (B) Local agents; and (C) Telephone number; (2) Each column shall contain the following information: (A) Bail Bond Company. The professional bail bond company 18 name and code number shall be typed in the first column on the left-hand side 19 of the page, with the home office address, city, state, zip code, and home 20 office telephone numbers directly under the company name in the same column. 21 No more than two (2) telephone numbers shall be listed for each company. The 22 order in which the company name appears on the list will stay in the same 23 order as it registered with the circuit clerk pursuant to this chapter; (B) Local Agents. The second column shall contain no more 25 than seven (7) names of local licensed agents per company for each county and 26 their code numbers.
