17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code 15-23-601 through 15-23-604, which provides
20 for the White River Valley Commission, is repealed.

31 ~~_____ (b) Nothing in this subchapter shall preclude any educational~~
32 ~~institution or state agency from assisting the White River Valley Commission.~~

35 ~~_____ The White River Valley Commission created by this subchapter shall have~~
36 ~~no authority over that portion of the White River located in Stone County.~~

SECTION 2. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 3. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.
