8	REQUESTING THE ARKANSAS DEVELOPMENT FINANCE AUTHORITY
9	(ADFA) TO ESTABLISH A PORT FACILITIES REVOLVING LOAN FUND
10	TO AID LOCAL PORT AUTHORITIES IN THE ACQUISITION AND

14	REQUESTING THE ADFA ESTABLISH A PORT
15	FACILITIES REVOLVING LOAN FUND TO AID
16	LOCAL PORT AUTHORITIES IN ACQUIRING AND
17	DEVELOPING OF PORT FACILITIES.
18	
19	WHEREAS, metropolitan port authorities, municipal port authorities, and
20	any other ports or harbor facilities operated by a local government or jointly
21	operated by local governments in Arkansas need assistance to develop plans for
22	existing ports and harbor facilities in updating or building new
23	infrastructure and developing new services for port and harbor facilities and
24	for providing new port and harbor facilities along the various navigable
25	waterways of this state which do not have available the benefits or services
26	of ports and harbors facilities; and
27	
28	WHEREAS, it is necessary for the local governments in Arkansas operating
29	port and harbor facilities to coordinate the efforts of these local political
30	subdivisions for the purpose of making maximum use of the services and
31	resources of this state in providing port and harbor facilities in this state
32	for the economic benefit of the local areas, the development of jobs, and the
33	transportation of goods to and from Arkansas; and

35	WHEREAS, the Arkansas Development Finance Authority (ADFA) has served as
36	a central agency for the State of Arkansas in issuing industrial development

1 bond financing and in launching innovative industrial and economic development 2 financing programs for state and local development agencies; and WHEREAS, the Arkansas Development Finance Authority (ADFA) is authorized 4 5 to create flexible programs to benefit industrial and economic development for 6 the State of Arkansas and its political subdivisions for the economic benefit 7 of the local areas, the development of jobs, and the transportation of goods 8 into and out of Arkansas, 9 10 NOW THEREFORE, 11 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FIRST GENERAL 12 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN: 13 THAT the General Assembly of the State of Arkansas respectfully requests 14 15 the Arkansas Development Finance Authority establish a revolving loan program 16 of approximately \$2 million for the acquisition and development of port and 17 harbor facilities or facilities equipment in Arkansas and also establish a 18 system of priorities for eligibility for loans from a Port Facilities 19 Revolving Loan Fund to acquire and develop the port and harbor facilities and 20 facilities equipment for the port authorities of the various local political 21 subdivisions in Arkansas; and 22 FURTHER RESOLVED THAT a copy of this resolution, after its concurrence 23 24 by the Senate, be sent by the Chief Clerk of the House to the Executive 25 Director of the Arkansas Development Finance Authority for presentation to the 26 Authority at its next scheduled meeting. 27 28 29 30 31 32 33 34 35
