- 8 Tempore of the Senate may, by joint proclamation, reconvene the General
- 9 Assembly before 12:00 noon, May 2, 1997, for the purpose of considering
- 10 executive vetoes, correcting errors and oversights, considering legislation
- 11 relating to the Eighty-First Session Projects Account in the General
- 12 Improvement Fund, including but not limited to Senate Bill 676, and
- 13 considering the need for further extension of the Eighty-First General
- 14 Assembly, or may adjourn the General Assembly any time before that date if
- 15 they determine it is not necessary to reconvene. If the General Assembly is
- 16 not reconvened before 12:00 noon, May 2, 1997, the regular session of the
