33	SECTION 2. FU	NDING TRANSFER. Immediately upo	on the effective date of
34	this Act, the Chief Fiscal Officer of the State shall transfer on his books		
35	and those of the State Treasurer the sum of Five Hundred Two Thousand Three		
36	Hundred Forty Dollars (\$502.340) from the General Revenue Allotment Reserve

- 4 SECTION 3. During the 1996-97 fiscal year, the Director of the
- 5 Department of Education General Education Division, with the approval of the
- 6 Chief Fiscal Officer and after review by the Arkansas Legislative Council or
- 7 Joint Budget Committee, is hereby authorized to request appropriation
- 8 transfers from the Regular Salaries and Personal Services Matching line items
- 9 to the Professional Fees and Services line items authorized for the General
- 10 Education Division, specifically for the purpose of hiring counsel to
- 11 represent the Department of Education in legal matters pertaining to school
- 12 finance.
- 13 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
- 14 authorized by this Act shall be limited to the appropriation for such agency
- 15 and funds made available by law for the support of such appropriations; and
- 16 the restrictions of the State Purchasing Law, the General Accounting and
- 17 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
- 18 Procedures and Restrictions Act, or their successors, and other fiscal control
- 19 laws of this State, where applicable, and regulations promulgated by the
- 20 Department of Finance and Administration, as authorized by law, shall be
- 21 strictly complied with in disbursement of said funds.

- 23 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General
- 24 Assembly that any funds disbursed under the authority of the appropriations
- 25 contained in this Act shall be in compliance with the stated reasons for which
- 26 this Act was adopted, as evidenced by the Agency Requests, Executive
- 27 Recommendations and Legislative Recommendations contained in the budget
- 28 manuals prepared by the Department of Finance and Administration, letters, or
- 29 summarized oral testimony in the official minutes of the Arkansas Legislative
- 30 Council or Joint Budget Committee which relate to its passage and adoption.

- 32 SECTION 6. CODE. All provisions of this Act of a general and permanent
- 33 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
- 34 Code Revision Commission shall incorporate the same in the Code.

SECTION 7. SEVERABILITY. If any provision of this Act or the 2 application thereof to any person or circumstance is held invalid, such 3 invalidity shall not affect other provisions or applications of the Act which 4 can be given effect without the invalid provision or application, and to this 5 end the provisions of this Act are declared to be severable. 6 7 SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict 8 with this Act are hereby repealed. 9 10 SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the 11 Eighty-First General Assembly that funds provided by the General Assembly for 12 the operations of the Department of Education - General Education Division 13 are, due to unforeseen circumstances, insufficient for the Department of 14 Education - General Education Division to continue to provide essential 15 governmental services; that the provisions of this act will provide the 16 necessary monies for the Department of Education - General Education Division 17 to continue such services; and that a delay in the effective date of this Act 18 could work irreparable harm upon the proper administration and provision of 19 essential governmental programs. Therefore, an emergency is hereby declared 20 to exist and this Act being necessary for the immediate preservation of the 21 public peace, health and safety shall be in full force and effect from and 22 after the date of its passage and approval. 23 /s/ Russ 24 25 26 27 28 29 30 31 32 33 34 35
