35		SECTION 5. SPECIAL LANGUAGE. SPECIAL ALLOW	ANCES. For the	e purpose of

- 1 providing necessary allowances for housing and other unusual expenses incurred
- 2 by or in behalf of the athletic director, assistant athletic directors, head
- 3 coaches, and assistant coaches at Arkansas State University, the Board of
- 4 Trustees may make special allowances available therefor in such amounts as the
- 5 Board of Trustees may determine as justified, an equitable allowance in view
- 6 of the unusual and exacting duties of said athletic director, assistant
- 7 athletic directors, head coaches, and assistant coaches, and for the purpose
- 8 of providing such allowances, the Board of Trustees is authorized to expend
- 9 from the auxiliary income of the Arkansas State University, which is derived
- 10 from athletic event receipts, an amount not to exceed twenty thousand dollars
- 11 (\$20,000) in the aggregate for such purposes during each year of the 1997-99
- 12 biennium for the athletic director and head coaches, and ten thousand dollars
- 13 (\$10,000) in the aggregate for such purposes during the  $1997 ext{-}99$  biennium for
- 14 the assistant athletic directors and assistant coaches. Provided that any such
- 15 allowances shall be in addition to the regular salary of such athletic
- 16 director, assistant athletic directors, head coaches and assistant coaches, as
- 17 established herein provided that the amount of such allowance shall not exceed
- 18 ten thousand dollars (\$10,000) per annum for any one salaried position.
- 19 Further, Arkansas State University shall report annually to the Legislative
- 20 Joint Auditing Committee the exact disposition of the special allowance funds
- 21 authorized herein.

- 23 SECTION 6. SPECIAL LANGUAGE. Upon determination by the President of
- 24 Arkansas State University that a reallocation of resources for purposes of
- 25 reorganization or consolidation of administrative functions within the
- 26 university is necessary for efficient and effective operations of the
- 27 university, the president, with approval of the Arkansas State University
- 28 Board of Trustees, may have the authority to transfer positions,
- 29 appropriations and related funds between campuses, divisions, branches, and
- 30 other budgetary units of Arkansas State University. The transfers of
- 31 positions, programs, or activities shall be used for those purposes for which
- 32 the appropriations were approved by the General Assembly. The transfers,
- 33 consolidation, or reorganization which involve academic programs shall be
- 34 reviewed by the Department of Higher Education and the Legislative Council.

35

SECTION 7. SPECIAL LANGUAGE. HOUSING ALLOWANCE. Upon approval by the 2 Arkansas State University Board of Trustees, the Chancellor or Director, if there is no Chancellor, of the various branch campuses of Arkansas State University may receive a housing allowance in an amount not to exceed four 5 hundred dollars (\$400) per month in lieu of college housing. 6 7 SECTION 8. Notwithstanding any law to the contrary, the Board of Trustees of Arkansas State University may hereafter lease facilities or 9 operations for room and board purposes in any manner and upon terms the board 10 deems to be in the best interest of the university. Action taken under this 11 act shall be by written resolution adopted by at least a majority of the 12 members of the board. 13 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 14 15 authorized by this Act shall be limited to the appropriation for such agency 16 and funds made available by law for the support of such appropriations; and 17 the restrictions of the State Purchasing Law, the General Accounting and 18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 19 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions 20 Act, or their successors, and other fiscal control laws of this State, where 21 applicable, and regulations promulgated by the Department of Finance and 22 Administration, as authorized by law, shall be strictly complied with in 23 disbursement of said funds. 24 25 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General 26 Assembly that any funds disbursed under the authority of the appropriations 27 contained in this Act shall be in compliance with the stated reasons for which 28 this Act was adopted, as evidenced by the Agency Requests, Executive 29 Recommendations and Legislative Recommendations contained in the budget 30 manuals prepared by the Department of Finance and Administration, letters, or 31 summarized oral testimony in the official minutes of the Arkansas Legislative 32 Council or Joint Budget Committee which relate to its passage and adoption. 33 SECTION 11. CODE. All provisions of this Act of a general and 34 35 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and

1	the Arkansas Code Revision Commission shall incorporate the same in the Code.
2	
3	SECTION 12. SEVERABILITY. If any provision of this Act or the
4	application thereof to any person or circumstance is held invalid, such
5	invalidity shall not affect other provisions or applications of the Act which
6	can be given effect without the invalid provision or application, and to this
7	end the provisions of this Act are declared to be severable.
8	
9	SECTION 13. GENERAL REPEALER. All laws and parts of laws in conflict
10	with this Act are hereby repealed.
11	
12	SECTION 14. EMERGENCY CLAUSE. It is hereby found and determined by the
13	Eighty-First General Assembly, that the Constitution of the State of Arkansas
14	prohibits the appropriation of funds for more than a two (2) year period; that
15	the effectiveness of this Act on July 1, 1997 is essential to the operation of
16	the agency for which the appropriations in this Act are provided, and that in
17	the event of an extension of the Regular Session, the delay in the effective
18	date of this Act beyond July 1, 1997 could work irreparable harm upon the
19	proper administration and provision of essential governmental programs.
20	Therefore, an emergency is hereby declared to exist and this Act being
21	necessary for the immediate preservation of the public peace, health and
22	safety shall be in full force and effect from and after July 1, 1997.
