- 11 for Slaughter/Bulk Meat".

- 13 SECTION 17. SPECIAL LANGUAGE. Notwithstanding any other provision of
- 14 law or departmental commitment which may exist to the contrary, the State
- 15 Board of Correction and Community Punishment shall not increase any
- 16 reimbursement rate for payments made to any county for the purpose of
- 17 reimbursing the expenses of the care and custody of state inmates, without
- 18 first seeking and receiving the approval of the Governor and the Chief Fiscal
- 19 Officer of the State.

- 21 SECTION 18. SPECIAL LANGUAGE EXTRA SALARIES. USE OF MAINTENANCE AND
- 22 OPERATION APPROPRIATION AND SALVAGED MATERIALS CONSTRUCTION. The Department
- 23 of Correction is hereby authorized to utilize Maintenance and General
- 24 Operation Appropriation in conjunction with surplus and/or salvageable
- 25 materials for the purpose of implementing construction projects to benefit the
- 26 Department and its various programs. Before such projects may be undertaken, a
- 27 Method of Finance must be submitted for prior review by the Arkansas
- 28 Legislative Council or Joint Budget Committee, and review and approval by the
- 29 Department of Finance and Administration and the Arkansas State Building
- 30 Services.

- 32 SECTION 19. SPECIAL LANGUAGE EXTRA SALARIES. There is hereby
- 33 authorized, for the Department of Correction, for the 1997-99 biennium, the
- 34 following increases in salaries for certain positions provided in the Regular
- 35 Salary schedule in this Act, and to be in addition to the annual amounts as

- 1 established by the Uniform Classification and Compensation Act, as amended,
- 2 for full-time physicians who are certified by the American Specialty Boards at
- 3 rates of pay not to exceed an additional \$4,500 per year. If certified in
- 4 forensic psychiatry, an additional \$2,500 per year will be allowed. Total
- 5 extra salaries may not exceed \$7,000 per year per position. In the event the
- 6 physician is not a full time employee, the amount specified herein shall be
- 7 adjusted proportionately to the amount of time worked for the Department of
- 8 Correction by that physician.

9

- 10 SECTION 20. SPECIAL LANGUAGE. In the event the Department of Correction
- 11 cannot accept inmates from county jails due to insufficient bed space, the
- 12 Department shall reimburse the counties at a rate determined by the Board of
- 13 Correction and Community Punishment until the appropriation provided for such
- 14 purpose is exhausted. The prevailing rate of the county jail will be
- 15 considered by the Board in determining the rate to be reimbursed. The
- 16 appropriation provided by Item (08) of Section 3 may also be used for
- 17 contracts with county jails for pre-release inmates.

18

- 19 SECTION 21. SPECIAL LANGUAGE In the event of a substantial increase
- 20 in utility rates, the Department of Correction is authorized to transfer any
- 21 line item appropriation in this Act to the Maintenance and Operation line item
- 22 for support of the increase after receiving approval of the Chief Fiscal
- 23 Officer of the State.

24

- 25 SECTION 22. SPECIAL LANGUAGE TRANSFER OF APPROPRIATION WITHIN CAPITAL
- 26 IMPROVEMENT PROJECTS. The Department of Correction is hereby authorized to
- 27 transfer appropriation between and/or among the various capital
- 28 improvements/construction projects authorized by the General Assembly. Such
- 29 transfers may be made only after approval by the Governor and after prior
- 30 review by the Arkansas Legislative Council or Joint Budget Committee. Such
- 31 authorization shall in no way mean that the total amount of funds or
- 32 appropriations for capital improvement/construction projects be greater than
- 33 that provided by the General Assembly for the Department of Correction.

35 SECTION 23. SPECIAL LANGUAGE - MENTAL HEALTH SERVICES. In the event the

1 Department determines to enter into a professional contract for mental health

- 2 services, the Department may, upon approval of the Chief Fiscal Officer of the
- 3 State and after prior review by the Arkansas Legislative Council or Joint
- 4 Budget Committee, make appropriate transfers from regular salaries, personal
- 5 services matching and various maintenance and operation classifications to the
- 6 professional fees and services classification for payment of the contractual
- 7 amount.

8

- 9 SECTION 24. SPECIAL LANGUAGE. The Department of Correction is
- 10 authorized to transfer funds from various Special Revenue and Cash Funds into
- 11 the Inmate Care and Custody Fund Account in order to adjust to the budget
- 12 needs upon approval of the Board of Correction and Community Punishment and
- 13 the Chief Fiscal Officer of the State.

14

- 15 SECTION 25. SPECIAL LANGUAGE NEW FACILITIES. If it is found that
- 16 contracting for the operation of new facilities is economically beneficial to
- 17 the State of Arkansas, the Department of Correction may, after receiving
- 18 approval of the Chief Fiscal Officer, and seeking prior review by the Arkansas
- 19 Legislative Council or Joint Budget Committee, transfer from any line item
- 20 appropriation contained in Section 3 of this Act into the Professional Fees
- 21 and Services line item contained in Section 3 of this Act to operate new
- 22 facilities opened during the biennium.

23

- 24 SECTION 26. SPECIAL LANGUAGE. The Department of Correction is hereby
- 25 authorized to transfer appropriations between any line items authorized herein
- 26 but only for the purpose of financing construction or equipment for a facility
- 27 of the department. Any transfers authorized by this section shall require the
- 28 approval of the Chief Fiscal Officer of the State after prior review by the
- 29 Legislative Council or Joint Budget Committee.

- 31 SECTION 27. SPECIAL LANGUAGE REALLOCATION OF RESOURCES. Upon
- 32 determination by the Board of Correction and Community Punishment that a
- 33 reallocation of resources within the Department of Community Punishment and
- 34 Department of Correction is necessary for the efficient and effective
- 35 operation of the departments, the Board, with approval of the Governor and

- 1 review by the Arkansas Legislative Council or Joint Budget Committee, shall
- 2 have the authority to instruct the department directors, to request from the
- 3 Chief Fiscal Officer of the State, a transfer of positions, programs, funds,
- 4 appropriations, and line-item appropriations within or between existing and
- 5 newly created divisions, offices, sections, or units of the departments. If
- 6 it is determined that the requested transfer should be made, the Chief Fiscal
- 7 Officer of the State shall then initiate the necessary transfer documents to
- 8 reflect the transfers upon the fiscal records of the State Treasurer, the
- 9 State Auditor, the Chief Fiscal Officer of the State, and the Departments of
- 10 Correction and Community Punishment.

11

- 12 SECTION 28. SPECIAL LANGUAGE HAZARDOUS DUTY PAY. The Department of
- 13 Correction is hereby authorized to pay hazardous duty pay to provide special
- 14 compensation to eligible security personnel to compensate for the increased
- 15 risk of personal injury. The hazardous duty pay authorized herein shall not
- 16 exceed an amount equal to five and one-half percent (5.5%) of the annual
- 17 salary authorized by law to any eligible employee and shall only be made
- 18 available to the personnel occupying the following positions.

- 30 Employees assigned to these classifications may be eligible for hazardous duty
- 31 pay if the Director of the Department of Correction certifies to the Chief
- 32 Fiscal Officer that employees in these positions have been assigned direct
- 33 supervision of inmates which requires these positions to be exposed to
- 34 increased risk of personal injury.

1 Employees in the above classifications who are assigned to maximum security lockup areas, i.e. administrative, segregation, punitive isolation and death row at the maximum security unit, Cummins Unit, and East Arkansas Regional Unit, are authorized to receive the hazardous duty pay allowance and an additional amount of maximum security incentive pay to five and one-half percent of the annual salary authorized by law. This pay will only be paid while the employee continues to work in the maximum security lockup areas and pay will be discontinued should the employee terminate work in this area. 9 The amounts received under the provisions of this section shall not be 10 considered as exceeding the maximum authorized annual salary allowance for employees in receipt of such amounts. Such amounts shall be considered as Regular Salary and the Department of Finance and Administration shall adopt the necessary rules and regulations for the administration of this provision. 15 16 Employees covered by the provisions of this Section shall be eligible for special compensation for hazardous duty and additional compensation for maximum security assignment only upon a determination by the Chief Fiscal Officer of the State that sufficient general revenues are available to sustain payment of the additional compensation levels herein authorized. It is the 2.0 intent of this section that such payments shall be optional, at the discretion 22 of the Chief Fiscal Officer of the State and the Director of the Department of Correction, dependent upon sufficient revenues and shall not be implemented using funds specifically set aside for other programs within the Department. 25 26 SECTION 29. In the event the Department is able to contract with a private provider for food services at a unit(s), transfers may be made from Regular Salaries, Personal Services Matching, and Maintenance and Operations line items to Professional Fees and Services upon notification by the Chief Fiscal Officer of the State and after receiving prior review by the Legislative Council or Joint Budget Committee. 31 32 33 SECTION 30. SPECIAL LANGUAGE. In the event the Department of 34 Correction is able to install a lethal electric fence around the perimeter of 35 the states' institutions, a reduction of personnel currently stationed in

1 towers could be realized. Any savings realized from reductions in Regular

- 2 Salaries, Personnel Services Matching or other line items associated with the
- 3 staff, may be transferred to appropriate line items for the installation,
- 4 maintenance, and operation of the electric fence upon approval by the Chief
- 5 Fiscal Officer of the State after receiving prior review by the Arkansas
- 6 Legislative Council or Joint Budget Committee.

- 8 SECTION 31. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
- 9 authorized by this Act shall be limited to the appropriation for such agency
- 10 and funds made available by law for the support of such appropriations; and
- 11 the restrictions of the State Purchasing Law, the General Accounting and
- 12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
- 13 Procedures and Restrictions Act, or their successors, and other fiscal control
- 14 laws of this State, where applicable, and regulations promulgated by the
- 15 Department of Finance and Administration, as authorized by law, shall be
- 16 strictly complied with in disbursement of said funds.

- 18 SECTION 32. LEGISLATIVE INTENT. It is the intent of the General
- 19 Assembly that any funds disbursed under the authority of the appropriations
- 20 contained in this Act shall be in compliance with the stated reasons for which
- 21 this Act was adopted, as evidenced by the Agency Requests, Executive
- 22 Recommendations and Legislative Recommendations contained in the budget
- 23 manuals prepared by the Department of Finance and Administration, letters, or
- 24 summarized oral testimony in the official minutes of the Arkansas Legislative
- 25 Council or Joint Budget Committee which relate to its passage and adoption.

- 27 SECTION 33. CODE. All provisions of this Act of a general and
- 28 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the
- 29 Arkansas Code Revision Commission shall incorporate the same in the Code.

- 31 SECTION 34. SEVERABILITY. If any provision of this Act or the
- 32 application thereof to any person or circumstance is held invalid, such
- 33 invalidity shall not affect other provisions or applications of the Act which
- 34 can be given effect without the invalid provision or application, and to this
- 35 end the provisions of this Act are declared to be severable.

2	SECTION 35. GENERAL REPEALER. All laws and parts of laws in conflict				
3	with this Act are hereby repealed.

5	SECTION 36. EMERGENCY CLAUSE. It is hereby found and determined by the				
6	Eighty-First General Assembly, that the Constitution of the State of Arkansas				
7	prohibits the appropriation of funds for more than a two (2) year period; that				
8	the effectiveness of this Act on July 1, 1997 is essential to the operation of				
9	the agency for which the appropriations in this Act are provided, and that in				
10	the event of an extension of the Regular Session, the delay in the effective				
11	date of this Act beyond July 1, 1997 could work irreparable harm upon the				
12	proper administration and provision of essential governmental programs.				
13	Therefore, an emergency is hereby declared to exist and this Act being				
14	necessary for the immediate preservation of the public peace, health and				
15	safety shall be in full force and effect from and after July 1, 1997.
