These objectives are to: 26 (1) Establish a state plan for an information technology 27 infrastructure; 2.8 (2) Implement increased capabilities for communication and 29 exchange of information; 30 (3) Establish standards for information technology; 31 (4)Develop mechanisms for more timely acquisition of information 32 technology; 33 (5) Establish policies and procedures that maximize the return on investment of information technology expenditures. 34 (d)(1) The General Assembly further finds and determines that 35 36 information technology services are readily available in the private sector;

- 1 that the public interest would be well-served by competition for the provision
- 2 of such services to the State; that public-private partnerships or joint

- 16 storage, manipulation, transmission, retrieval, and presentation of
- 17 information in the form of data, text, voice, or image and includes
- 18 telecommunications and office automation functions;
- 19 (6) Telecommunications means all forms of communications devices and
- 20 transport medium for conveyance of voice, words, data, signals, or images, by
- 21 electronic or electrical means;
- 22 (7) Network infrastructure means the shared portions of the State $\overline{\mathbf{a}}$ s
- 23 telecommunications transmission facilities, including all transmission lines
- 24 and all associated equipment and software components necessary for management
- 25 and control of the State network;
- 26 (8) Equipment means the machines, devices, and transmission facilities
- 27 used in information processing, including computers, word processors,
- 28 terminals, telephones, cables, software and related services;
- 29 (9) Application means a separately identifiable and interrelated set
- 30 of information technology resources that allows a state agency to accomplish
- 31 information processing to support specifically defined objectives;
- 32 (10) Information technology resources means the procedures, equipment,
- 33 and software that are designed, built, operated, and maintained to collect,
- 34 record, process, store, retrieve, display, and transmit information, and
- 35 associated personnel including consultants and contractors;
- 36 (11) Project means a program to apply information technology resources

- 1 to functions within or among elements of a state agency, that ideally is
- 2 characterized by well-defined parameters, specific objectives, common
- 3 benefits, planned activities, a scheduled completion date, and an established
- 4 budget with a specified source of funding;
- 5 (12) State agencies means all state departments, boards, commissions,
- 6 and institutions of higher learning, but shall not include the elected
- 7 constitutional officers and their staffs, the Arkansas General Assembly and
- 8 its committees and staffs, or the Supreme Court and the Judicial Department;

- 22 "25-4-104. Powers and duties generally Department of Information Systems
- 23 Office of Information Technology.
- 24 In addition to the powers, functions, and duties of the department
- 25 provided elsewhere in this chapter, the department shall:
- 26 (1) Establish and operate a central data processing system, consisting of
- 27 the equipment, services, and programs which are necessary therefor, to meet
- 28 the data processing needs of the respective state agencies which have data
- 29 processing needs and funds therefor but do not have authority or capacity to
- 30 separately provide the data processing services to meet their needs:
- 31 (2) Enter into contracts with state agencies for the purpose of providing
- 32 data processing services and establish a system of uniform fees or special
- 33 charges, to be paid by the state agencies served, to enable the department to
- 34 defray the cost of providing the services as provided in this chapter;
- 35 (3) Establish and maintain adequate and accurate records of the cost of
- 36 operating the central data processing system and establish fair and reasonable

- 1 fee schedules to defray the cost of services rendered;
- 2 (4) Operate a central telephone service for state agencies, keep adequate
- 3 and accurate records of the cost of providing the central telephone services,
- 4 and establish fair and reasonable schedules of rates or fees, to be charged to
- 5 each user state agency, which are deemed necessary to provide the services and
- 6 defray the cost thereof;
- 7 (5) Establish and operate a technical assistance and evaluation staff to
- 8 assist the department in performing its duties and to provide data processing
- 9 services to state agencies in assisting them in determining the most
- 10 economical and efficient means of providing data processing services;
- 11 (6) Establish a means of technical evaluation to promote quality in data
- 12 processing, telecommunications, and telephone systems;
- 13 (7) Establish and maintain accurate records of technical evaluations for
- 14 providing information as requested by the Governor, the Arkansas
- 15 Communications Study Committee, and the General Assembly and its committees;
- 16 (8) Conduct advanced and current planning for meeting state agency needs
- 17 for data processing services, telecommunications services, and telephone
- 18 services, establish cost estimates for user agencies and the department in
- 19 providing the equipment and services necessary to meet those needs, and
- 20 coordinate the implementation of agency requests in such a manner as to avoid

- 34 (g) The director shall appoint such deputy and division directors, and
- 35 professional, technical, and clerical assistants and employees as necessary to
- 36 perform the duties imposed by this chapter. All employees of the department

- 1 shall be employed by and serve at the pleasure of the director.
- 2 (h) The director shall report to the Governor any matters relating to
- 3 abuses of this chapter.
- 4 (i) The director shall recommend statutory changes to the Governor."

- 7 follows:
- 8 "25-4-105. Data processing center Contracts with state agencies
- 9 Department of Information Systems General powers and duties.
- 10 (a) The department is authorized to establish and operate an electronic
- 11 data processing center and, in connection therewith, to rent, purchase,
- 12 install, operate, and maintain electronic data processing equipment and
- 13 supplies and perform data processing services for state agencies as authorized
- 14 in this chapter.
- 15 <u>(b)(1) The department is authorized to enter into contracts or agreements</u>
- 16 with state agencies for the purpose of providing data processing services.
- 17 (2) All state agencies are authorized to utilize the services of the
- 18 central electronic data processing center operated by the department.
- 19 (3) It is the specific intention of this subsection to authorize, but not
- 20 to mandate, state departments and agencies which currently operate their own
- 21 data processing units to enter into agreements with the department for data
- 22 processing services at their option.
- 23 (4) Because of the complex technical and engineering processes carried
- 24 out for the State Highway Commission by that commission's computer services,
- 25 as structured to serve present and potential need, it is the further intention
- 26 of this subsection to authorize the continuance of these services and to allow
- 27 the State Highway Commission access to additional storage and capacity
- 28 provided by the Department of Computer Services upon mutual agreement by the
- 29 Director of State Highways and Transportation and the Director of the
- 30 Department of Computer Services.
- 31 The Department of Information Systems shall be vested with all the
- 32 powers and duties necessary to administer the department and to enable it to
- 33 carry out fully and effectively the regulations and laws relating to the
- 34 department. These powers and duties relate to information technology and
- 35 include but are not limited to:
- 36 (1) Providing over<u>sight of the Office of Information Technology;</u>

- 1 (2) Providing information technology services to state agencies and
- 2 other governmental entities;
- 3 (3) Entering into contracts with state agencies and other governmental
- 4 entities for the purpose of providing information technology services;
- 5 (4) Establishing fair and reasonable schedules of rates or fees to be
- 6 paid by state agencies and governmental entities provided service to enable
- 7 the department to defray the cost of providing the services as provided in
- 8 this chapter;
- 9 (5) Establishing rates and fees for services provided by the department
- 10 to assure that the department is self-supporting. A billing rate plan shall
- 11 be developed for a two-year period to coincide with the budgeting process.
- 12 The same rate structure will apply to all agencies and entities receiving
- 13 service;
- 14 (6) Acquiring information technology on behalf of state agencies, the
- 15 cost of which shall be recovered through customer billings at established
- 16 rates;
- 17 (7) Promulgating rules and regulations that are necessary for efficient
- 18 administration and enforcement of the powers, functions, and duties of the
- 19 department as provided in this chapter;
- 20 (8) Developing a departmental plan to achieve the goals and objectives
- 21 set forth in the State Information Technology Plan. The department shall seek
- 22 the advice of appropriate steering committees in the development of these
- 23 plans;
- 24 (9) Performing any additional powers, functions, and duties which are
- 25 necessary and appropriate for the proper administration of the provisions of
- 26 this chapter.
- 27 (10) Setting policies by regulation, reviewing applications, and
- 28 recommending projects to the Governor for consideration for award of grant or
- 29 loan funds from the available sources, including the Telecommunications and
- 30 Information Technology Fund, for the continued development and enhancement of
- 31 educational opportunities, medical care services, and government operations
- 32 throughout the State of Arkansas through the use of the state
- 33 telecommunications network employing advanced communications and information
- 34 technology."

36 SECTION 6. Arkansas Code Annotated 6 25-4-106 is amended to read as

- 1 follows:
- 2 "25-4-106. Central telephone service Report to Joint Committee -
- 3 Appointment of advisory board and steering committee.
- 4 (a) The department is authorized to develop, install, maintain, and
- 5 operate a central telephone service for state agencies.
- 6 (b) The department shall have power and authority to enter into
- 7 agreements and contracts with public utilities for providing the central
- 8 telephone service.
- 9 (c) The central telephone service operated by the department shall be
- 10 made available to all state agencies which fall within economical and feasible
- 11 boundaries of the central telephone service as determined by the director.
- 12 (a) The director will report periodically and annually to the Joint
- 13 Committee on Advanced Communications and Information Technology regarding the
- 14 status of information technology in state government. The director will
- 15 forward to the Joint Committee any statutory changes that the department may
- 16 recommend sufficiently in advance of the convening of the regular session of
- 17 the Arkansas General Assembly. The director may report on any factors that
- 18 are outside the scope of the department but are deemed to inhibit or to
- 19 promote the effective exchange and use of information in state government.
- 20 (b) Subject to the following provisions, the governor shall appoint the

- 28 (4) Members shall not receive compensation for service to the
- 29 board;
- 30 (5) Members may receive reimbursement for actual and necessary
- 31 expenses reasonably incurred in performing board service, subject to
- 32 applicable limitations on reimbursement as provided by law.
- 33 (c) Subject to the following provisions, the governor shall appoint the
- 34 Department of Information Systems Steering Committee to provide advice to the
- 35 director concerning services provided by the department:
- 36 (1) Members of the committee shall be agency directors or their

- 1 designee and shall include, but not be limited to:
- 2 (A) Two (2) members from a list of nominees submitted by
- 3 the presidents and chancellors of the states public institutions, one (1) of
- 4 whom shall be employed by a two-year institution and one (1) of whom shall be
- 5 employed by a four-year institution;
- 6 (B) One (1) member who is employed by a state agency with
- 7 less than fifty (50) employees;
- 8 (C) One (1) member who is employed by a state agency with
- 9 between fifty (50) and five hundred (500) employees;
- 10 (D) One (1) member who is employed by a state agency with
- 11 over five hundred (500) employees and having a state-wide presence; and
- 12 (E) One (1) member who has knowledge and experience
- 13 regarding information technology in the states public schools.
- 14 (2) Members of the committee shall annually elect a chair;
- 15 (3) The committee may be convened by a majority of members, by
- 16 its chair, or by the director;
- 17 (4) Members shall not receive compensation for service on the
- 18 committee;
- 19 (5) Members may receive reimbursement for actual and necessary
- 20 expenses reasonably incurred in performing committee service, subject to
- 21 applicable limitations on reimbursement as provided by law.
- 22 (d) The director may appoint other committees as are necessary to
- 23 provide the department with expertise and advice concerning information
- 24 technology or the services provided by the department."

- 26 SECTION 7. Arkansas Code Annotated $^{\circ}$ 25-4-107 is amended to read as
- 27 follows:
- 28 "25-4-107. Agency acquisition of data processing and telecommunications
- 29 equipment or services Approval required Office of Information Technology -
- 30 General powers and duties.
- 31 <u>(a) Without first making a request to the director for approval, state</u>
- 32 agencies supported in whole or in part from revenues or moneys of this state
- 33 shall not:
- 34 (1) Acquire by purchase or lease any new or additional data processing or
- 35 telecommunications equipment, machinery, or services; or
- 36 (2) Expand existing data processing or telecommunications machinery,

- 1 equipment, or services of the state agency; or
- 2 (3) Enter into any contract for data processing or telecommunications
- 3 planning or services.
- 4 (b) Because of the complex technical and engineering processes carried
- 5 out for the State Highway Commission by that commission's computer services,
- 6 as structured to serve present and potential need, those services shall be
- 7 continued without regard to the provisions of this chapter in order to best
- 8 serve the transportation needs of the state. However, the State Highway
- 9 Commission shall inform the committee of all new acquisitions or expansions of
- 10 computer equipment or programs undertaken by the Arkansas State Highway and
- 11 Transportation Department. The State Highway Commission may request the
- 12 assistance of the services of the Department of Computer Services with respect
- 13 to computer expansion or services at the State Highway Commission's
- 14 discretion.
- 15 The Office of Information Technology shall be vested with all the powers
- 16 and duties necessary to carry out regulations and laws relating to the
- 17 department and to oversee and administer information technology and shall:
- 18 (1) Assist the department in performing its duties;
- 19 (2) Review agencies' information technology plans and requests;
- 20 (3) Provide leadership in coordinating information technology;
- 21 (4) Advise agencies in acquiring information technology service;
- 22 (5) Advise agencies regarding information technology contracts and
- 23 agreements;
- 24 (6) Monitor national and international standards relating to
- 25 information technology;
- 26 (7) Develop and publish policies, procedures, and standards relating to
- 27 information technology and ensure agencies' compliance with those policies,
- 28 procedures, and standards;
- 29 (8) Develop standards to promote and facilitate electronic access to
- 30 government information and inter-operability of information systems;
- 31 (9) Develop a state information technology plan that shall establish a
- 32 state-level mission, goals, and objectives for the use of information
- 33 technology;
- 34 (10) Foster interagency use of information technologies that is
- 35 consistent with the established strategic direction of information technology
- 36 and avoids unnecessary duplication."

- 15 (11) "Universal access" means access to the public telecommunications

- 19 (a) The Governor may establish the Governor's Telecommunications and
- 20 Information Technology Advisory Board for the purposes of aggregating funding
- 21 and other resource commitments of state, federal, telecommunications industry,
- 22 and other private sector contributors and for carrying out other duties
- 23 established by this subchapter.
- 24 (b) The board will assist in the funding of telecommunications
- 25 application projects, promoting universal and public access and efforts to
- 26 educate users about telecommunications, and creating incentive programs for
- 27 agencies adopting technology that promotes economic and social development,

- 29 any person or circumstance is held invalid, such invalidity shall not affect
- 30 other provisions or applications of the act which can be given effect without
- 31 the invalid provision or application, and to this end the provisions of this
- 32 act are declared to be severable.

- 34 SECTION 34. All laws and parts of laws in conflict with this act are
- 35 hereby repealed.

1	SECTION 35. EMERGENCY. It is found and determined by the Eighty-First
2	General Assembly that continuing advances in the field of communications and
3	information technology make it necessary to establish a Department of
4	Information Systems within the Executive Department of Government to better
5	coordinate and utilize such technology; and that in the event of an extension
6	of the Regular Session, the delay in the effective date of this act beyond
7	July 1, 1997, could work irreparable harm upon the proper administration and
8	provision of essential governmental programs. Therefore, an emergency is
9	hereby declared to exist, and this Act being necessary for the immediate
10	preservation of the public peace, health, and safety shall be in full force
11	and effect from and after July 1, 1997.
