28	Judicial District, is amended to read as follows:
29	"SECTION 4. (a) The Council is authorized to employ a director and such
30	other personnel as it deems necessary and appropriate to assure the effective
31	and efficient operation of the detention facility.
32	(b) The Council, by a majority vote of its members, may elect to
33	participate in the Arkansas Public Employees Retirement System and to include
34	its full-time employees within the membership of the Arkansas Public Employees
35	Retirement System. The Council may pay the contributions as the Arkansas
36	Public Employees Retirement System Board of Trustees shall prescribe."

2 SECTION 2. Arkansas Code 24-4-101(5), regarding the definitions 3 affecting the Public Employees Retirement System, is amended to read as 4 follows:

5 "(5) _Participating public employer_ means any county, municipality, 6 rural waterworks facilities board, regional airport authority, public 7 facilities board, regional solid waste management board, joint county and 8 municipal sanitation authority, or regional water distribution board, in the 9 state whose employees are included in the membership of the system <u>or the</u> 10 <u>employees of the Intergovernmental Juvenile Detention Council who are included</u> 11 in the membership of the system;"

SECTION 3. Arkansas Code 24-4-101(9), regarding the definitions affecting the Public Employees Retirement System, is amended to read as follows:

16 "(9) _Nonstate employees_ means county employees, municipal employees, 17 rural waterworks facilities board employees, regional airport authority 18 employees, public facilities board employees, regional solid waste management 19 board employees, joint county and municipal sanitation authority employees, 20 regional water distribution board employees and school employees <u>and the</u> 21 <u>employees the Intergovernmental Juvenile Detention Council</u>;"

23 SECTION 4. Arkansas Code 24-4-101, regarding the definitions affecting 24 the Public Employees Retirement System, is amended to add a new subdivision 25 (32) to read as follows:

26 "<u>(32)</u>_Intergovernmental Juvenile Detention Council_ means the
27 Intergovernmental Juvenile Detention Council of the 10th Judicial District
28 created by uncodified Act 899 of 1995, which has chosen by a majority vote of
29 the Council to participate in the Arkansas Public Employees Retirement

32 SECTION 5. Arkansas Code 24-4-202(e), regarding contributions to the 33 Arkansas Public Employees Retirement System Fund, is amended to read as 34 follows:

35 "(e)(1) In the case of regional airport authority employees, public 36 facilities board employees, rural waterworks facilities board employees,

1 regional solid waste management board employees, joint county and municipal 2 sanitation authority employees, and regional water distribution board 3 employees, <u>Intergovernmental Juvenile Detention Council employees</u>, each 4 participating employer shall pay into the Arkansas Public Employees' 5 Retirement System Fund such sums of money as are necessary to provide the 6 employer's contribution, as directed by the Board of Trustees of the Arkansas 7 Public Employees' Retirement System. 8 (2) The contribution shall be transmitted to the Arkansas Public

13 SECTION 6. (a) Any full-time employee of the Intergovernmental 14 Juvenile Detention Council of the Tenth Judicial District enrolled in the 15 Arkansas Public Employees Retirement System pursuant to this act, who is a 16 full-time employee of the Council on the date his employer becomes a public 17 employer in the System, may apply for and receive current service credit for 18 service rendered as a full-time employee of the Intergovernmental Juvenile 19 Detention Council. The employee shall receive credit only if the employee or 20 employer pays, or causes to be paid, to the Arkansas Public Employees 21 Retirement System Fund all necessary employer contributions and employee 22 contributions, if applicable, that would have been paid had the employee been 23 a member of the Arkansas Public Employees Retirement System during that time, 24 plus interest thereon at the rate directed by the Board of Trustees of the 25 Arkansas Public Employees Retirement System. The employer's contributions and 26 employees' contributions, if applicable, shall be transmitted to the System in 27 the form and manner, together with the supporting data, as the Arkansas Public 28 Employees Retirement System Board of Trustees shall prescribe from time to 29 time. 30 (b) The Intergovernmental Juvenile Detention Council of the Tenth 31 Judicial District electing to include the full-time employees of the Board 32 within the membership of the Arkansas Public Employees Retirement System may pay the employer contributions and employee contributions, if applicable, on 33 behalf of employees for services rendered. 34 35

SECTION 7. All provisions of this act of general and permanent nature

1 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 2 Revision Commission shall incorporate the same in the Code. 3 4 SECTION 8. If any provisions of this act or the application thereof to 5 any person or circumstance is held invalid, the invalidity shall not affect 6 other provisions or applications of the act which can be given effect without 7 the invalid provisions or application, and to this end the provisions of this 8 act are declared to be severable. 9 10 SECTION 9. All laws and parts of laws in conflict with this act are 11 hereby repealed. 12 13 SECTION 10. Emergency. It is hereby found and determined by the 14 Eighty-First General Assembly of the State of Arkansas that the 15 Intergovernmental Juvenile Detention Council of the Tenth Judicial District 16 created by uncodified Act 899 of 1995 should be entitled to participate in the 17 Public Employees Retirement System at the beginning of the next fiscal year; 18 and that unless this emergency clause is adopted this act might not become 19 effective until after the beginning of the next fiscal year.
