17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

         SECTION 1. Arkansas Code Annotated 6 16-10-133 is amended to read as

         (a)(1) Beginning July 1, 1996, positions shall be authorized and funds

23 appropriated to the Auditor of State from the State Administration of Justice
24 Fund to provide one (1) staff person for each of the judges of the circuit,
25 chancery, and probate courts. The staff person may be employed to perform
26 secretarial, docketing, and management services. Each judge of the circuit,
27 chancery, or probate court shall report to the Administrative Office of the
28 Courts his intention to employ such a staff person. Two (2) or more judges
29 within a judicial district may employ jointly, in their discretion, one (1)
30 staff person when coordinated with the Administrative Office of the Courts.

                (2) When any judge employs a part-time staff person at a part-time
32 salary or does not employ a full-time staff person, but rather employs a staff
33 person to share with another judge, then by written notification to the

- 20 SECTION 2. All provisions of this act of a general and permanent nature
- 21 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 22 Revision Commission shall incorporate the same in the Code.

- 24 SECTION 3. If any provision of this act or the application thereof to
- 25 any person or circumstance is held invalid, such invalidity shall not affect
- 26 other provisions or applications of the act which can be given effect without
- 27 the invalid provision or application, and to this end the provisions of this
- 28 act are declared to be severable.

- 30 SECTION 4. All laws and parts of laws in conflict with this act are
- 31 hereby repealed.
