1 (B) No two (2) of the three (3) bail bondsman members shall 2 reside in the same congressional district, and at least one (1) of the bail 3 bondsman members shall be an African-American. (3) The board shall have the authority and responsibility to administer 5 and enforce the provisions of this chapter relating to licensing and 6 regulation of professional bail bond companies and professional bail bondsmen. All provisions of this act of a general and permanent 21 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 22 Code Revision Commission shall incorporate the same in the Code. 23 24 SECTION 4. If any provision of this act or the application thereof to 25 any person or circumstance is held invalid, such invalidity shall not affect 26 other provisions or applications of the act which can be given effect without 27 the invalid provision or application, and to this end the provisions of this 28 act are declared to be severable. 29 30 SECTION 5.
