18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:				
19					
20	SECTION 1.	As used in this act:			
21	(a) "Accredited veterinarian" means a veterinarian licensed by the				
22	Arkansas Veterinary Medical Examining Board and approved by the United States				
23	Department of Agriculture, Animal and Plant Health Inspection Service (USDA,				
24	APHIS) to perform functions required for state or cooperative state/federal				
25	animal disease cont	rol and eradication programs.			
26	(b) "Adjacent herds" means a group or groups of Equidae sharing common				
27	pasture or having other direct contact with an affected herd or reactor animal				
28	and herds containing previous purchases from or exchanges with an affected				
29	herd. Herds separated by a distance of less than four hundred forty (440)				
30	yards are considered adjacent herds.				
31	(c) "Affected herd" means a herd of Equidae that contains or has				
32	contained one or more animals infected with equine infectious anemia and that				
33	has not passed the required tests necessary for release from quarantine.				
34	(d) "Approved laboratory" means a laboratory which is approved by the				
35	USDA and the State Veterinarian to conduct an official test for equine				
36	infectious anemia.				

- 1 (e) "Approved market" means a stockyard, livestock market or other
- 2 premises, approved by the Commission where Equidae are congregated for sale.
- 3 (f) "Authorized agent" means a person who has been authorized by the
- 4 Arkansas Livestock and Poultry Commission to act on its behalf in making
- 5 investigations, inspections, performing other services or acts which have been
- 6 defined by this act.
- 7 (g) "Certificate of Veterinary Inspection" means an official document
- 8 issued by an accredited veterinarian at the point of origin of a shipment of
- 9 Equidae. It shall include: (1) the name, breed, registration number if any,
- 10 implanted electronic identification transponder number if any, tattoo if any,
- 11 brand if any, sex, age, color and markings sufficient to positively identify
- 12 each Equidae listed on the form; (2) a record of a physical examination of
- 13 each animal verifying freedom from visible evidence of any contagious,
- 14 infectious or communicable diseases and the results of an official test for
- 15 equine infectious anemia, including the name of the approved laboratory, the
- 16 case number and the date of the most recent test results; and (3) the Equidae
- 17 temperature reading.
- 18 (h) "Certified EIA Verifier" means any certificate holder having
- 19 completed the prescribed training course co-sponsored by the Arkansas
- 20 Livestock and Poultry Commission, the University of Arkansas Extension Service
- 21 and the Arkansas Horse Council.
- 22 (i) "Commission" means the Arkansas Livestock and Poultry Commission.
- 23 (j) "Concentration Point" means the gathering of one or more Equidae,
- 24 for any purpose, at a single location, facility, or area whereby Equidae will
- 25 be within four hundred forty (440) yards from each other.
- 26 (k) "Designated Epidemiologist" means an experienced licensed
- 27 epidemiologist who has been designated by the state veterinarian to perform
- 28 those functions necessary for the classification of Equidae, based on the
- 29 evaluation of test results and consideration of the animal and herd history as
- 30 well as other epidemiologic factors including, but not limited to, weather
- 31 conditions, number of vectors in the area, and concentration of animals.
- 32 (1) "Equidae" means a family of perissodactyl ungulate mammals
- 33 containing a single genus Equus, which includes horses, asses, jacks, jennies,
- 34 hennies, mules, donkeys, burros, ponies and zebras.
- 35 (m) "Equine Activity" means:
- 36 (A) Equine shows, fairs, competitions, performances or parades

- 1 that involve any or all breeds of equines and any of the equine disciplines,
- 2 including but not limited to, dressage, hunter and jumper horse shows, grand
- 3 prix jumping, three day events, combined training, rodeos, pulling, cutting,
- 4 polo, steeplechasing, endurance trail riding and western games, and hunting;
- 5 (B) Equine training and teaching activities;
- 6 (C) Boarding equines;
- 7 (D) Riding, inspecting, or evaluating an equine belonging to
- 8 another, whether or not the owner has received some monetary consideration or
- 9 other thing of value for the use of the equine or is permitting a prospective
- 10 purchaser of equine to ride, inspect, or evaluate the equine; and
- 11 (E) Rides, hunts, or other equine activities of any type, no
- 12 matter how informal or impromptu.
- 13 (n) 'Equine infectious anemia', 'EIA', or 'EIAV' mean the communicable
- 14 infectious disease which affects Equidae and is caused by the virus of equine
- 15 infectious anemia.
- 16 (o) "Exposed Equidae" means Equidae that have been in contact with,
- 17 associated with, adjacent to, or within four hundred forty (440) yards of
- 18 animals known to be EIA reactors.
- 19 (p) "Herd" means one or more Equidae of single or multiple ownership
- 20 maintained on common ground or one or more Equidae under single or multiple
- 21 ownership that are geographically separated but that can have an interchange
- 22 or movement without regard to health status.
- 23 (q) "Livestock dealer" means any person engaged in the business of
- 24 buying or selling livestock including Equidae in commerce, on a commission
- 25 basis or any person registered and bonded under the provisions of the Federal
- 26 Packers and Stockyards Act of 1921, as amended, who buys or sells Equidae.
- 27 The term "livestock dealer" does not include a farmer or rancher who buys or
- 28 sells livestock or Equidae in the ordinary course of his farming or ranching
- 29 operation.
- 30 (r) "Neighboring herd" means one or more Equidae residing within four
- 31 hundred forty (440) yards of another premise containing Equidae and which
- 32 other premise is owned, leased or caretaken by different individuals,
- 33 partnerships or corporations. Temporary additions of Equidae, regardless of
- 34 length of time, are considered part of neighboring herds.
- 35 (s) "Negative current EIA test" means a negative response to an
- 36 official EIA test conducted by an approved laboratory within the past twelve

- 1 months.
- 2 "Official EIA test" means the agar gel immunodiffusion (AGID) test, (t)
- also known as the "Coggins" test, the competitive enzyme-linked immunosorbent
- assay (CELISA) test, the synthetic antigen enzyme linked immunosorbent assay
- (SA-ELISA) test and any other USDA licensed tests approved by the Commission.
- 6 "Participant" means any person, whether amateur or professional,
- who engages in an equine activity, whether or not a fee is paid to participate
- in the equine activity.
- 9 "Permit" or "permit for movement" means an official document issued
- by the Commission, a representative of APHIS-VS or an accredited veterinarian
- 11 authorizing the movement of a reactor or exposed Equidae to a quarantined
- 12 holding facility, an approved slaughter facility or approved quarantined
- The permit shall list the name, breed, registration number if any, premise.
- tattoo if any, implanted electronic identification transponder number if any,
- brand if any, sex, age, color and markings sufficient to positively identify
- each Equidae listed on the form. The owners name and address, origin and
- destination locations and purpose of the movement shall also be recorded. 17
- 18 "Quarantine" means a written notice or order issued by the
- Commission showing the boundaries of the area or premise affected, the Equidae
- 20 restricted and the restrictions, if any.
- 21 "Quarantined holding facility" means a quarantined premise approved
- 22 by the Commission to handle reactors or exposed Equidae.
- "Reactor" means any Equidae which reacts positively to an official 23
- 24 EIA test.
- 25 "Regulatory veterinarian" means a veterinarian employed by or
- acting as an agent for the Commission.
- 27 Epidemiologist investigation means the process used by the
- 2.8 Designated Epidemiologist to classify Equidae.
- 30

- SECTION 2. Testing Requirements for Domiciled Equidae.
- 31 All Equidae domiciled within the State of Arkansas shall be
- subjected to an official EIA test every twelve months. An Equidae is
- domiciled within the state when the Equidae has been pastured, stabled, 33
- housed, or kept in any fashion in the state more than thirty consecutive or
- 35 unconsecutive days. Written proof of a negative current official EIA test
- 36 shall be made available in the form of negative results from an approved

- 1 laboratory upon request made by an authorized representative of the
- 2 Commission, or the owner/lessee/caretaker of a neighboring herd.
- 3 (b) Owners of horses domiciled within the state shall be responsible
- 4 for maintaining a negative current official EIA test on all horses that they
- 5 own. After January 1, 1998, failure to furnish proof of negative current
- 6 official EIA test to an authorized agent of the Commission may result in
- 7 quarantine and penalties prescribed by Sections 26 and 27. Owners of
- 8 neighboring herds, whether of single or multiple ownership shall have the
- 9 right to know if any equine within four hundred forty (440) yards are
- 10 untested, exposed or reactor animals.
- 11 (c) When any Equidae is examined or treated by an accredited
- 12 veterinarian, the owner or caretaker must present to the veterinarian written
- 13 proof of a negative current official EIA test. If no official EIA test
- 14 results are available, the accredited veterinarian may draw an official sample
- 15 for EIA as part of the examination or treatment, at the owners expense.

- 17 SECTION 3. Equidae Identification Requirements.
- 18 All Equidae domiciled within Arkansas and over the age of six months or
- 19 weaned from mare shall be positively identified on the official EIA test form
- 20 by an accredited veterinarian or an agent of the Commission by means of
- 21 distinctive markings, color patterns, previous brand, previous tattoo,
- 22 previously implanted electronic transponder number, permanent scars, other
- 23 blemishes, cowlicks, whorls, lip tattoo, hot brand or freeze brand prior to an
- 24 EIA test.

25

- 26 SECTION 4. Authority to require test.
- 27 Any equidae which have been within four hundred forty (440) yards of a
- 28 reactor shall be subject to testing by the Commission, the State Veterinarian
- 29 or their agents if the exposure to the reactor occurred no more than thirty
- 30 (30) days prior to the testing of the reactor.

31

- 32 SECTION 5. Personnel authorized to collect blood samples.
- 33 All samples collected from Equidae for equine infectious anemia testing
- 34 shall be collected by an accredited veterinarian, State Veterinarian, or other
- 35 Commission authorized personnel.

1 SECTION 6. Submission of sample and test charts. 2 All blood samples submitted for official EIA tests must be accompanied 3 by a properly completed VS Form 10-11 (Equine Infectious Anemia Laboratory Test) or other form prescribed by the Commission. Photocopies of the form shall not be considered an official record of test. 6 7 SECTION 7. Requirements for Arkansas approved EIA testing laboratories. 8 No person, firm or corporation shall initiate operation of an EIA testing laboratory without first obtaining approval from the Commission. 10 11 SECTION 8. Classification of Equidae tested. 12 All Equidae tested shall be classified as either negative or reactor. 13 Reactors may be retested at the owners expense provided the owner or the owners agent initiates a retest request to the State Veterinarian not more than five (5) working days after the receipt of the test results by the owner or the owner's agent. All retest samples shall be collected by the same accredited veterinarian who conducted the original test or an alternate 18 accredited veterinarian appointed by the State Veterinarian, and submitted to 19 an approved laboratory within twenty (20) days after the receipt by the owner or the owner's agent of the first positive test. The veterinarian collecting the retest sample shall be provided documentation that the animal being 22 retested is the one shown positive on the initial test. All reactors shall be 23 held in isolation, under quarantine, while awaiting the retest results. All other Equidae on the premises shall be held under quarantine while awaiting 25 the retest results. Retest results shall be the official results unless there 26 are conflicting tests. If there are conflicting tests, a third test shall be conducted in the presence of an authorized agent of the commission or by an 28 authorized agent of the Commission. The sample will be sent to the Arkansas 29 Livestock and Poultry Commission diagnostic laboratory. Costs will be borne 30 by the state unless an accredited veterinarian draws the sample, which will be 31 paid for by the owner. Results of two out of three tests will determine 32 classification.

- 34 SECTION 9. Reporting of test results.
- 35 It is the responsibility of the approved laboratory to notify the State
- 36 Veterinarians office and the individual submitting the sample for testing

- 1 within twenty-four hours after classifying an Equidae as a reactor. It is the
- 2 responsibility of the individual collecting the test sample to notify the
- 3 reactors owner or the owners agent of the results of all positive tests
- 4 within forty-eight hours after classification and to notify the animals owner
- 5 or the owners agent of the quarantine resulting from positive test results.

- 7 SECTION 10. Quarantines.
- 8 (a) All reactors shall be quarantined by an authorized agent of the
- 9 Commission to the premises of origin or other premises designated by the owner
- 10 and approved by the Commission. The quarantine shall restrict the reactors,
- 11 all other Equidae on the premises and all Equidae epidemiologically determined
- 12 by the Commission to have been exposed to a reactor. All Equidae on affected
- 13 premises shall be isolated at least four hundred forty (440) yards away from
- 14 all Equidae on adjacent premises and at least four hundred forty (440) yards
- 15 from any public road. It is the responsibility of the owner of reactors to
- 16 maintain those animals in isolation at least four hundred forty (440) yards
- 17 away from any public road and all other Equidae. The quarantine may be
- 18 released by an authorized agent of the Commission after all quarantined
- 19 Equidae in the affected herd test negative to an official EIA test not less
- 20 than sixty (60) days nor more than eighty (80) days following the
- 21 identification and removal of the last reactor, or as determined by the
- 22 designated epidemiologist.
- 23 (b) No Equidae held under quarantine may be moved or released until a
- 24 written permit or quarantine release, signed by an authorized agent, has been
- 25 executed.
- 26 (c) All adjacent herds, neighboring herds, and other exposed equine, so
- 27 deemed by epidemiological investigation, will be guarantined by written report
- 28 by an authorized agent.
- 29 (d) Deviations in testing requirements for quarantines are acceptable
- 30 when made by the designated epidemiologist.

- 32 SECTION 11. Quarantining reactors.
- 33 (a) With the exception of the equine stabled at a racetrack regulated
- 34 by the Arkansas State Racing Commission, all reactors shall be quarantined to
- 35 the owners premises or an approved quarantine holding facility and shall be
- 36 destroyed or sold for immediate slaughter or permitted to a research facility

- 1 within twenty (20) days after the date of the last official positive EIA test.
- 2 If the equidae is destroyed, or dies of natural causes within the twenty (20)
- 3 day period, verification of the destruction or death by written and signed
- 4 statement from an accredited veterinarian or an authorized agent of the
- 5 Commission must be furnished to the office of the State Veterinarian. If sold
- 6 for slaughter, the Equidae may be moved from the owners premises to an
- 7 approved market or to an approved slaughter facility provided that the Equidae
- 8 are accompanied by a permit for movement. The owner or trainer of reactors
- 9 stabled at a racetrack regulated by the Arkansas State Racing Commission shall
- 10 be notified immediately by the testing veterinarian, racetrack officials, or
- 11 by Commission personnel and the reactors shall be removed from the racetrack
- 12 premises immediately.
- 13 (b) Exceptions.
- 14 (1) Upon request by the owner, any female reactor that is at
- 15 least two hundred seventy days pregnant or has a nursing foal less than four
- 16 (4) months of age (as verified by an accredited veterinarian or an agent of
- 17 the Commission) at her side may be quarantined to the owners premises and
- 18 shall be kept at least four hundred forty (440) yards away from any other
- 19 Equidae. The reactor shall be identified with a "71A" brand, or other brand
- 20 prescribed by the Commission, at least two (2) inches in height on the left
- 21 shoulder or left side of neck. The female reactor may remain in quarantine
- 22 until her foal dies or reaches an age of four (4) months at which time the
- 23 reactor shall either be destroyed, shipped by permit to an approved
- 24 quarantined holding facility, or sold for immediate slaughter within twenty
- 25 (20) days. If the equidae is destroyed, or dies from natural causes,
- 26 verification of destruction by written and signed statement must be furnished
- 27 to the office of the State Veterinarian by an accredited veterinarian or an
- 28 agent of the Commission. If sold for slaughter, the reactor may be moved from
- 29 the owners premises to an approved market or to an approved slaughter
- 30 facility provided that the reactor is accompanied by a permit for movement.
- 31 (2) Any foal kept in quarantine with its EIA positive dam shall
- 32 be officially tested for EIA at the owners expense not less than sixty (60)
- 33 days nor more than eighty (80) days after it is weaned. Foals nursing
- 34 positive mares must be weaned at four (4) months of age.
- 35 (3) Any Equidae which tested positive to the official EIA test
- 36 prior to the effective date of this act shall be quarantined to the owners

- 1 premises and kept at least four hundred forty (440) yards away from any other
- 2 Equidae or public road. The reactor shall be identified with a "71A" brand,
- 3 or other brand prescribed by the Commission, at least two inches in height on
- 4 the left shoulder or left side of neck. If the reactor is sold, it must be
- 5 sold for slaughter and a VS Form 1-27 or permit must be issued by Commission
- 6 personnel to move the reactor from the owners premises to slaughter.
- 7 Ownership of reactors may not be changed except for slaughter. If the reactor
- 8 is destroyed or dies, verification of destruction or death by written and
- 9 signed statement must be furnished to the office of the State Veterinarian,
- 10 certified by an accredited veterinarian, or an agent of the Commission.
- 11 (4) Any reactor found in violation of quarantine shall be ordered
- 12 sold for slaughter or destroyed within twenty (20) days, and the owner or
- 13 caretaker will be subject to prosecution for noncompliance.

- 15 SECTION 12. Positive reactors at official racetracks.
- 16 All equine stabled at a racetrack regulated by the Arkansas State Racing
- 17 Commission which test positive to the official EIA test shall be immediately
- 18 removed from the racetrack, shall be quarantined to the premises to which they
- 19 are moved and shall be destroyed, branded by authorized Commission personnel,
- 20 sold for immediate slaughter or by permit shipped to an approved quarantined
- 21 holding facility within twenty (20) days after the date of the last official
- 22 positive EIA test. If destroyed or dies of natural causes within the twenty
- 23 (20) days, a written and signed statement by an accredited veterinarian or an
- 24 agent of the Commission must be furnished to the office of the State
- 25 Veterinarian. If the equidae is sold for slaughter, the equine may be moved
- 26 from the owners premises to an approved market or to an approved slaughter
- 27 facility provided that the equine is accompanied by a permit for movement.

28

- 29 SECTION 13. Testing requirements in affected herds.
- 30 All Equidae determined to have been on the same premises as a reactor at
- 31 the time the reactor was bled, shall be tested by an accredited veterinarian
- 32 or an authorized agent of the Commission at the owners expense sixty (60) to
- 33 eighty (80) days after the reactors last positive test result. Foals less
- 34 than four (4) months of age nursing negative tested dams, are exempt from
- 35 testing.

- 1 SECTION 14. Movement of reactors and exposed animals.
- 2 All reactors and exposed Equidae must be accompanied by a permit for
- 3 movement when moved from their quarantined premises. All reactors must be
- 4 branded prior to moving interstate. Movement of reactors and exposed Equidae
- 5 must be direct to an approved slaughter facility or a quarantined holding
- 6 facility for movement to an approved slaughter facility. Any other move such
- 7 as a change in location of reactors or exposed Equidae to an alternate
- 8 quarantined premise must be approved in advance following an epidemiological
- 9 investigation by the State Veterinarian or other designated Commission
- 10 personnel. Such movement must also be accompanied by a permit for movement.
- 11 If a change in destination becomes necessary, a new permit must be issued by
- 12 Commission authorized personnel, or the regulatory veterinarian.

- 14 SECTION 15. Requirements for quarantined holding facilities.
- 15 (a) Any person desiring to operate a quarantined holding facility must
- 16 file an application for approval of the facility on forms provided by the
- 17 Commission. The facility must have an area where Equidae testing positive to
- 18 an official EIA test and exposed Equidae are kept, and where the Equidae are
- 19 isolated and confined at least four hundred forty (440) yards from all other
- 20 Equidae at all times. The facility must be approved by the Commission
- 21 pursuant to an inspection of the premises prior to the issuance of the
- 22 license. Failure to maintain the reactors and exposed Equidae in confinement
- 23 and isolation at least four hundred forty (440) yards from all other Equidae
- 24 at all times is a violation of this act. All Equidae held in a quarantined
- 25 holding facility must be shipped direct to an approved slaughter facility
- 26 without diversion. Animals moved from a quarantined holding facility may not
- 27 go through any livestock auction facility prior to shipment to slaughter. All
- 28 movements from a quarantined holding facility must be accompanied by a permit
- 29 for movement.
- 30 (b) All Equidae entering or within an approved quarantine holding
- 31 facility shall be branded or show evidence of an "S" brand on the top of the
- 32 left hip or a 71-A brand (or other brand prescribed by the Commission) on the
- 33 left shoulder or neck, not less than two (2) inches in height.
- 34 (c) No Equidae may be held over twenty (20) days.
- 35 (d) Quarantine pens must be clearly identified by a sign or paint using
- 36 the word "Quarantined" on all sides. Letters of the sign must be a minimum

1 of one (1) foot in height. 2 (e) Failure to comply with this act shall be cause for cancellation of approval by the Commission. 4 5 SECTION 16. Fictitious names and erroneous information. Test charts, permits and other official forms must be completed in the 6 name of the owner or the person responsible for the Equidae. No livestock auction facility operator or veterinarian may be held responsible for recording erroneous information provided by an owner, buyer or seller. individual providing the erroneous or fictitious information shall be deemed 11 to have violated this act. 12 SECTION 17. Testing requirements for change of ownership. 13 All Equidae which are sold, bartered, traded, given free of charge, 15 offered for sale, or any horses otherwise exchanged for any reason within Arkansas except at approved markets must be accompanied by a record of a negative EIA test conducted at an approved laboratory within the previous six (6) months. Photocopies of a VS Form 10-11 or other form prescribed by the 18 19 Commission shall not be considered an official record of the test. Foals, less than six (6) months of age, accompanied by, nursing, and included in 21 change of ownership with a negative tested mare, are exempt from the testing 22 requirements. Foals sold separately are required to have a negative current 23 official EIA test. On all private sales, trades or barters, i.e., any sale other than through an approved market, both the buyer and the seller are equally and individually responsible for meeting the EIA testing requirements 26 prior to the sale or change of ownership. 27 2.8 SECTION 18. Movement of Equidae through approved market. 29 (a) All Equidae offered for sale or sold at approved markets must: 30 (1) be accompanied by written proof of a negative EIA test conducted within the last six (6) months, or 32 (2) have a blood sample collected by an accredited veterinarian or an authorized agent of the Commission at the market and test negative to an official EIA test performed by an approved laboratory before the animal leaves 35 the market, or

(3) have a blood sample collected by an accredited veterinarian

- 1 or an authorized agent of the Commission at the market and be quarantined to
- 2 the market until negative results are received from an approved laboratory, or
- 3 (4) be "S" branded and consigned to slaughter before receiving
- 4 test results, or
- 5 (5) be allowed to return to their premises of origin prior to
- 6 unloading and prior to consignment and be quarantined to the premises of
- 7 origin until tested negative (must be tested within thirty (30) days).
- 8 (b) Photocopies of a VS Form 10-11 or other form prescribed by the
- 9 Commission shall not be considered an official record of test.
- 10 (c) Foals less than six (6) months of age sold with and nursing
- 11 negative tested mares are exempt from the testing requirements of this act.
- 12 (d) Known reactors or known exposed Equidae shall not be consigned for
- 13 sale at approved markets unless permitted by authorized Commission personnel.
- 14 Those animals which are found to be reactors or exposed through testing
- 15 conducted at an approved market must be maintained in quarantine pens and
- 16 isolated from all other Equidae in the sale facility. The quarantine pens
- 17 must be clearly identified by sign or paint using the word "Quarantined" on
- 18 all sides. Letters must be one foot (1) high.
- 19 (e) It is the market owners responsibility to make sure that all
- 20 equine sold meet these requirements.

- 22 SECTION 19. Requirements of Equidae participating in equine activities.
- 23 (a) All Equidae moving within the state to Equidae exhibitions,
- 24 including but not limited to, fairs, livestock shows, breed association shows,
- 25 rodeos, trail rides, parades, team pennings, team ropings, racetracks or other
- 26 Equidae concentration points shall be accompanied by a record of a negative
- 27 current official EIA test within the past twelve (12) months.
- 28 (b) A photocopy of a VS Form 10-11 or other form prescribed by the
- 29 Commission shall not be accepted as an official record of test.
- 30 (c) Any show or event within the state may require any tests or
- 31 requirements they deem necessary.

- 33 SECTION 20. General requirements for Equidae entering Arkansas.
- 34 All Equidae entering Arkansas must be accompanied by a record of a
- 35 negative current official EIA test. All Equidae must also be accompanied by
- 36 a certificate of veterinary inspection, listing information from a record of a

- 1 negative official EIA test, the name and address of the consignor and
- 2 consignee, the number of animals in the shipment and a description which
- 3 accurately identifies each animal. Foals under six (6) months old accompanied
- 4 by a negative dam do not have to be tested for EIA.

- 6 SECTION 21. Requirements of Equidae moving within the state:
- 7 All Equidae moving within the state for any reason shall be accompanied
- 8 by a negative current official EIA test.

- 10 SECTION 22. Entry requirements to a veterinarians clinic for care or
- 11 treatment.
- 12 Equidae may enter Arkansas when consigned directly to a veterinary
- 13 hospital or clinic for treatment or for usual veterinary procedures when
- 14 accompanied by an owner/shipper permit. Following release by the
- 15 veterinarian, Equidae must be returned immediately to the state of origin by
- 16 the most direct route or meet testing requirements for additional movements.

- 18 SECTION 23. Entry requirements to an approved slaughter facility.
- 19 All Equidae consigned to an approved slaughter facility must be properly
- 20 and individually identified and accompanied by a waybill, bill of lading,
- 21 permit, or certificate of veterinary inspection. Known reactors must be
- 22 branded and known exposed animals must be properly identified and accompanied
- 23 by a permit.

24

- 25 SECTION 24. Penalties and fines.
- 26 Any person, firm or corporation who violates any of the provisions of
- 27 this act shall, upon conviction, be quilty of a Class A misdemeanor.

- 29 SECTION 25. Rules, regulations and orders.
- 30 (a) The Commission is authorized to promulgate, modify, and enforce
- 31 such rules, regulations and orders, not inconsistent with law as it shall from
- 32 time to time deem necessary to effectively carry out the provisions of this
- 33 act.
- 34 (b) Except as otherwise provided in this act, any person or entity who
- 35 violates provisions of this act and Commission regulations promulgated
- 36 pursuant to this act shall be deemed guilty of a Class A misdemeanor.

         In order to fund or partially fund the Equine Infectious Anemia Control
   and Eradication Program, the commission may, by appropriately adopted
   administrative rules and regulations, design and maintain a fee structure for
   the purpose of defraying the cost of services performed.

         The fees collected shall be deposited in the State Treasury as special
 8 revenues and shall be credited to the Livestock and Poultry Equine Infectious
 9 Anemia Control Fund hereby created on the books of the State Treasurer, State
