1 application thereof to any person or circumstance is held invalid, such 2 invalidity shall not affect other provisions or applications of the Act which 3 can be given effect without the invalid provision or application, and to this 4 end the provisions of this Act are declared to be severable. 5 6 SECTION 9. GENERAL REPEALER. All laws and parts of laws in conflict 7 with this Act are hereby repealed. 8 9 SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the 10 Eighty-First General Assembly, that the Constitution of the State of Arkansas 11 prohibits the appropriation of funds for more than a two (2) year period; that 12 the effectiveness of this Act on July 1, 1997 is essential to the operation of 13 the agency for which the appropriations in this Act are provided, and that in 14 the event of an extension of the Regular Session, the delay in the effective 15 date of this Act beyond July 1, 1997 could work irreparable harm upon the 16 proper administration and provision of essential governmental programs. 17 Therefore, an emergency is hereby declared to exist and this Act being 18 necessary for the immediate preservation of the public peace, health and 19 safety shall be in full force and effect from and after July 1, 1997. 20 /s/Mahony 21 22 23 24 25 2.6 27 28 29 30 31 32 33 34 35
