19	SECTION 1. Arkansas Code Annotated $^6$ 6-18-1004 is amended to read as

26	appropriate specialty or following a Department of Education Deficiency  Removal Plan will be assigned to carry out duties of each service.

- 2 (c)(1) Each school district plan shall provide for a district level
- 3 tracking system for school dropouts.
- 4 (2) The tracking system shall include provisions for student
- 5 services personnel in all schools to conduct an exit interview of students who
- 6 are dropping out of school and for follow-up of such students when possible.
- 7 (d) The superintendent of a school district not in substantial
- 8 compliance with the terms of its plan may be requested to appear before the
- 9 Interim Senate and House Committees on Education."

- 11 SECTION 2. Arkansas Code Annotated  $^{\circ}$  6-18-1005 is amended to read as
- 12 follows:
- "6-18-1005. Student services program defined.
- 14 (a) A student services program is defined as a coordinated effort
- 15 which shall include, but is not limited to:
- 16 (1) Guidance and counseling services, which shall include, but
- 17 are not limited to:
- 18 (A) The availability of individual and group counseling to
- 19 all students;
- 20 (B) Orientation programs for new students at each level of
- 21 education and for transferring students;
- 22 (C) Class scheduling for students Academic advisement for
- 23 class selection;
- 24 (D) Consultation with parents, faculty, and out-of-school
- 25 agencies concerning student problems and needs;
- 26 (E) Utilization of student records and files;
- 27 (F) Supervision Interpretation of standardized testing and
- 28 interpretation dissemination of results to the school community;
- 29 (G) The following-up of early school dropouts and
- 30 graduates;
- 31 (H) A school-initiated system of parental involvement;
- 32 (I) An organized system of informational resources on which
- 33 to base educational and vocational decision-making; and
- 34 (J) Educational and job placement career guidance,
- 35 including advising students on the availability of vocational and alternative
- 36 programs that could provide successful high school completing opportunities

- 1 for students at risk of dropping out of school; and
- 2 (K) Coordinating administration of the Test for Adult Basic
- 3 Education (T.A.B.E.) or the General Educational Development (G.E.D.) pre-test
- 4 to students by designating appropriate personnel, other than the school
- 5 guidance counselor, to administer the tests;
- 6 (L) Classroom guidance which shall be limited to thirty
- 7 (30) minute class sessions, not to exceed three (3) per day or ten (10) per
- 8 week;
- 9 (2) Psychological services, which shall include, but are not
- 10 limited to, the following:
- 11 (A) Evaluation of students with learning or adjustment
- 12 problems;
- 13 (B) Evaluation of students in exceptional-child education
- 14 programs;
- 15 (C) Consultation and counseling with parents, students, and
- 16 school personnel;
- 17 (D) A system for the early identification of learning
- 18 potential and factors which affect the child's educational performance;
- 19 (E) A system of liaison and referrals, with resources
- 20 available outside the school; and
- 21 (F) Written policies which assure ethical procedures in
- 22 psychological activities;
- 23 (3) Visiting teacher and school social work services, which shall
- 24 include, but are not limited to, the following:
- 25 (A) Providing casework to assist in the prevention and
- 26 remediation of problems of attendance, behavior, adjustment, and learning; and
- 27 (B) Serving as liaison between the home and school by
- 28 making home visits and referring students and parents to appropriate school
- 29 and community agencies for assistance;
- 30 (4) Occupational and placement services, which shall include, but
- 31 are not limited to, the dissemination of career education information,
- 32 placement services, and follow-up studies;
- 33 (5) Group conflict resolution services, which shall include, but
- 34 are not limited to, the following:
- 35 (A) Educational and social programs which help students
- 36 develop skills enabling them to resolve differences and conflicts between

- 1 groups; and
- 2 (B) Programs designed to promote understanding, positive
- 3 communication, and a greater utilization of a race relations specialist or
- 4 human relations specialist to assist in the development of intergroup skills;
- 5 (6) Health services; and
- 6 (7) The distribution of a suicide prevention public awareness
- 7 program developed for distribution by the inter program task force established
- 8 by the Lieutenant Governor's Teen age Suicide Prevention Task Force.
- 9 (b) School counselors shall spend at least seventy-five percent (75%)
- 10 of work time each week providing direct counseling related to students, and
- 11 shall devote no more than twenty-five percent (25%) of work time each week to
- 12 administrative activities, provided that such activities relate to the
- 13 provision of guidance services."

- 15 SECTION 3. Arkansas Code Annotated  $^{6}$  6-18-1007 is amended to read as
- 16 follows:
- "6-18-1007. School student services status report.
- 18 (a) By January 1, 1994, and each year thereafter, the Department of
- 19 Education shall compile and present to the Governor, the State Board of
- 20 Education, and the Joint Interim Senate and House Committee Committees on
- 21 Education a report outlining the status of implementing each of the provisions
- 22 of the Public School Student Services Act,  $^{\circ}$  6-18-1001 et seq., by the various
- 23 school districts, including which districts are in substantial compliance with
- 24 the plan required under 6 6-18-1004.
- 25 (b)(1) By January 1, 1998, the Department of Education shall have in
- 26 place a staffing structure that assures the department's administration and
- 27 field service staff are responsible for monitoring Department of Education and
- 28 local school district implementation and compliance with the provisions of
- 29 this subchapter. The Department of Education shall employ one (1) or more
- 30 persons, who shall have a minumum qualification of certification as school
- 31 counselors.
- 32 (2) Each school district shall be responsible for submitting a
- 33 quarterly report to the Assistant Director for Monitoring and Compliance,
- 34 Department of Education, outlining their compliance with and implementation
- 35 plans for the provisions of this act.
- 36 (3) The Assistant Director for Curriculum and Instruction and the

1 Assistant Director for Monitoring and Compliance shall designate an individual 2 or individuals who shall have a minimum qualification of certification as a 3 school counselor to be responsible for coordinating monitoring compliance with 4 this act. Such monitoring shall include interviews with administrators, 5 counselors, students, and teachers. The Department of Education shall submit 6 a quarterly report of monitoring findings to the Senate and House Interim Committees on Education." 8 9 SECTION 4. All provisions of this act of a general and permanent nature 10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 11 Revision Commission shall incorporate the same in the Code. 12 13 SECTION 5. If any provision of this act or the application thereof to 14 any person or circumstance is held invalid, such invalidity shall not affect 15 other provisions or applications of the act which can be given effect without 16 the invalid provision or application, and to this end the provisions of this 17 act are declared to be severable. 18 19 SECTION 6.
