11 ENHANCEMENT PROMOTION GROUP; AND FOR OTHER PURPOSES."

14 "TO CREATE THE ARKANSAS AGRICULTURAL
15 ENHANCEMENT PROMOTION GROUP."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. The Arkansas Agricultural Enhancement Promotion Group is
21 hereby created to be composed of:

22 (a) The Governor's designated representative;

23 (b) Vice President for Agriculture of the University of Arkansas;

24 (c) Executive Director, Arkansas Livestock and Poultry Commission;

25 (d) State Forester;

26 (e) Executive Director, Arkansas Soil and Water Conservation

27 Commission;

28 (f) Director, State Plant Board; and

29 (g) Director, Department of Economic Development.
30

31 SECTION 2. The group shall:

32 (1) communicate to the general public the importance of agriculture to
33 the State of Arkansas;

34 (2) establish ad hoc committees to develop projects relating to all
35 aspects of agriculture in Arkansas;

36 (3) present comprehensive projects to the Arkansas Economic Development

1 Commission for its advice;
2 (4) no later than January 1 of each year, report to the Governor of the
3 State of Arkansas on program activities; and
4 (5) promulgate regulations necessary for the implementation of this
5 act.

6
7 SECTION 3. Four (4) members of the group shall constitute a quorum.

8
9 SECTION 4. The Director of the Department of Economic Development shall
10 call the first meeting of the group and at that meeting the group shall elect
11 a chairman to serve for a term of one (1) year.

12
13 SECTION 5. The Department of Economic Development shall provide
14 administrative staff for the Arkansas Agricultural Enhancement Promotion
15 Group.

16
17 SECTION 6. All provisions of this Act of a general and permanent nature
18 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
19 Revision Commission shall incorporate the same in the Code.

20
21 SECTION 7. If any provision of this Act or the application thereof to
22 any person or circumstance is held invalid, such invalidity shall not affect
23 other provisions or applications of the Act which can be given effect without
24 the invalid provision or application, and to this end the provisions of this
25 Act are declared to be severable.

26
27 SECTION 8. All laws and parts of laws in conflict with this Act are
28 hereby repealed.
