REGULAR SALARIES - OPERATIONS. There is hereby established for the State Bank Department for the 1999-2001 biennium, the following maximum 23 24 number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 25 et seq.), or its successor, and all laws amendatory thereto. 26 however, that any position to which a specific maximum annual salary is set 27 28 out herein in dollars, shall be exempt from the provisions of said Uniform 29 Classification and Compensation Act.  SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the State Bank Department for the 1999-2001 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: three (3) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to the State Bank Department, to be payable from the Bank Department Fund, for personal services and operating expenses of the State Bank Department for the biennial period ending June 30, 2001, the following:

SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL RATES OF PAY. Due to the highly competitive job market conditions for banking industry professionals and the necessity of recruiting and retaining qualified personnel, the State Bank Department is authorized special rates of pay for current and new employees up to the levels listed under subsection (a), with additional authority and restrictions as indicated in subsections (b) and (c) below:

(a) Special rates may be authorized for the following classifications only, as indicated herein.

- (b) Applications for special rates of pay indicated in subsection (a) shall have been reviewed and approved by the Office of Personnel Management after prior review by the Arkansas Legislative Council.
- (c) This special provision shall be in full force and effect for the biennium beginning July 1, 1997 1999 and ending June 30, 1999 2001.

SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BANK EXAMINERS - RECRUITMENT. (a) Due to the necessity of recruiting and retaining qualified personnel, the following titles are available to the State Bank Department for the employment of bank examiners:

- (b) As bank examiner personnel qualify for promotion, the State Personnel Administrator may approve position reclassifications to a higher level classification employing the titles listed in subsection (a) of this section.
- (c) The State Bank Department shall be limited to a maximum of twentynine (29) thirty (30) filled positions in utilizing the title of Bank Senior Examiner/Grade 23 and fourteen (14) thirteen (13) filled positions in utilizing the title of Financial Examiner II/Grade 20. At no time during the 1997-99 1999-01 Biennium shall the combined use of both titles referenced in this subsection exceed forty-three (43) total.

SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 8. CODE. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 9. SEVERABILITY. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 10. GENERAL REPEALER. All laws and parts of laws in conflict with this act are hereby repealed.

SECTION 11. EMERGENCY CLAUSE. It is hereby found and determined by the Eighty-second General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1999 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1999 could work irreparable harm upon the proper administration and provision of essential governmental programs.

Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1999.
