9 "AN ACT TO PROVIDE CRIMINAL PENALTIES AND RESTITUTION
10 FOR KILLING OR INJURING SERVICE ANIMALS OR SEARCH AND
11 RESCUE DOGS; AND FOR OTHER PURPOSES."

14 "TO PROVIDE CRIMINAL PENALTIES AND
15 RESTITUTION FOR KILLING OR INJURING
16 SERVICE ANIMALS OR SEARCH AND RESCUE

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code 5-54-126 is amended to read as follows:

23 "5-54-126. Killing or injuring animals used by law enforcement or search
24 and rescue dogs.

25 (a) (1) Any person who, without just cause, purposely kills or injures
26 any animal owned by or used by a law enforcement agency or any search and
27 rescue dog shall be guilty of a Class D felony.

28 (2) 'Search and rescue dog' means any dog: (i) in training for or
29 trained for the purpose of search and rescue, (ii) owned by an independent
30 handler or member of a search and rescue team, and (iii) used in conjunction
31 with local law enforcement or emergency services organizations, for the
32 purpose of locating missing persons or evidence of arson.

33 (b) Any person guilty of violating subsection (a) of this section shall
34 also be required to make restitution to the law enforcement agency or owner so
35 aggrieved."

1 SECTION 2. Arkansas Code 20-14-304 is amended to read as follows:

2 "20-14-304. Right to be accompanied by service animal; Penalty and
3 restitution for killing or injuring a service animal or search and rescue dog.

4 (a) Every visually handicapped, hearing impaired, or other physically
5 disabled person shall have the right to be accompanied by a service animal
6 especially trained to do work or perform tasks for the benefit of an
7 individual with a disability in or upon any and all public ways, public
8 places, and other public accommodations and housing accommodations prescribed
9 in § 20-14-303 and shall not be required to pay any extra fee or charge for
10 the service animal.

11 (b) However, any visually handicapped, hearing impaired, or other
12 physically disabled person accompanied by a service animal in any public way,
13 public place, public accommodation, or housing accommodation shall be liable
14 for any damage caused to the premises or facilities by the animal.

15 (c) For purposes of this section, 'search and rescue dog' means any
16 dog: (1) in training for or trained for the purpose of search and rescue, (2)
17 owned by an independent handler or member of a search and rescue team, and (3)
18 used in conjunction with local law enforcement or emergency services
19 organizations, for the purpose of locating missing persons or evidence of
20 arson.

21 (d) Any person who, without just cause, purposely kills or injures any
22 service animal described in this section or any search and rescue dog is
23 guilty of a Class D felony.

24 (e) Any person who kills or injures any service animal described in
25 this section or any search and rescue dog shall make restitution to the owner
26 of the animal."

27
28 SECTION 3. All provisions of this act of a general and permanent nature
29 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
30 Revision Commission shall incorporate the same in the Code.

31
32 SECTION 4. If any provision of this act or the application thereof to
33 any person or circumstance is held invalid, such invalidity shall not affect
34 other provisions or applications of the act which can be given effect without
35 the invalid provision or application, and to this end the provisions of this
36 act are declared to be severable.
