9 "AN ACT TO AMEND ARKANSAS CODE 20-57-204 TO AMEND FOOD
10 SERVICE ESTABLISHMENT PERMIT FEES; TO AMEND THE
11 REFERENCES TO THE DIVISION OF SANITARIAN SERVICES TO
12 READ THE DIVISION OF ENVIRONMENTAL HEALTH PROTECTION;
13 AND FOR OTHER PURPOSES. "

16 "TO AMEND THE PERMIT FEES FOR FOOD
17 SERVICE ESTABLISHMENTS. "

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code 20-57-204(a) is amended to read as follows:

23 "(a) No food service establishment shall be allowed to operate unless
24 it has procured a food establishment permit from the Division of ~~Sanitarian~~
25 ~~Services~~ Environmental Health Protection of the Department of Health. "

26
27 SECTION 2. Arkansas Code 20-57-204 (c) through (e) are amended to read
28 as follows:

29 "(c) Any food service establishment may obtain a food service permit by
30 paying an annual permit fee of ~~twenty-five dollars (\$25.00)~~ thirty-five
31 dollars (\$35.00) to the Department of Health and by meeting the minimum
32 requirements established by the applicable rules and regulations.

33 (d)(1) Each distinctively separate food establishment type and class as
34 defined in §§ 20-57-201 - 20-57-205 shall be required to procure a permit for
35 that type or class per each location not to exceed a total of ~~seventy-five~~
36 ~~dollars (\$75.00)~~ one hundred and five dollars (\$105.00).

1 (2) On and after July 1, 2001 the fee provisions as set forth in this
 2 subsection shall be null and void, and any food service establishment may
 3 obtain a food service permit by meeting the minimum requirements established
 4 by the applicable rules and regulations.

5 (e) A temporary food establishment permit shall be procured from the
 6 Division of ~~Sanitarian Services~~ Environmental Health Protection of the
 7 Department of Health by any temporary facility operating at a fixed location
 8 for a period of not more than fourteen (14) consecutive days in conjunction
 9 with a single event or celebration. The fee of ~~twenty-five dollars (\$25.00)~~
 10 thirty-five dollars (\$35.00) shall be charged for each temporary food
 11 establishment permit. The permit shall be nonrenewable.”

12
 13 SECTION 3. All provisions of this act of a general and permanent nature
 14 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
 15 Revision Commission shall incorporate the same in the Code.

16
 17 SECTION 4. If any provision of this act or the application thereof to
 18 any person or circumstance is held invalid, such invalidity shall not affect
 19 other provisions or applications of the act which can be given effect without
 20 the invalid provision or application, and to this end the provisions of this
 21 act are declared to be severable.

22
 23 SECTION 5. All laws and parts of laws in conflict with this act are
 24 hereby repealed.
