21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. APPROPRIATIONS - CROSS COUNTY LIBRARY. There is hereby
24 appropriated, to the Department of Education - Arkansas State Library, to be
25 payable from the General Improvement Fund or its successor fund or fund
26 accounts, the following:

27 (A) For furniture and equipment for a children's wing of the Cross County
28 Library, the sum of \$60,000.
29

30 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
31 this act shall be limited to the appropriation for such agency and funds made
32 available by law for the support of such appropriations; and the restrictions
33 of the State Purchasing Law, the General Accounting and Budgetary Procedures
34 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
35 Restrictions Act, or their successors, and other fiscal control laws of this
36 State, where applicable, and regulations promulgated by the Department of

1 Finance and Administration, as authorized by law, shall be strictly complied
2 with in disbursement of said funds.

3
4 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
5 that any funds disbursed under the authority of the appropriations contained
6 in this act shall be in compliance with the stated reasons for which this act
7 was adopted, as evidenced by the Agency Requests, Executive Recommendations
8 and Legislative Recommendations contained in the budget manuals prepared by
9 the Department of Finance and Administration, letters, or summarized oral
10 testimony in the official minutes of the Arkansas Legislative Council or Joint
11 Budget Committee which relate to its passage and adoption.

12
13 SECTION 4. CODE. All provisions of this Act of a general and permanent
14 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
15 Code Revision Commission shall incorporate the same in the Code.

16
17 SECTION 5. SEVERABILITY. If any provision of this act or the application
18 thereof to any person or circumstance is held invalid, such invalidity shall
19 not affect other provisions or applications of the act which can be given
20 effect without the invalid provision or application, and to this end the
21 provisions of this act are declared to be severable.

22
23 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict with
24 this act are hereby repealed.

25
26 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
27 Eighty-second General Assembly, that funds were provided for the construction
28 of a children's wing of the Cross County Library; that private donations were
29 raised to equip the wing and that the donations were required to be used to
30 complete the construction phase, leaving no funds for furniture or equipment.
31 Therefore, an emergency is hereby declared to exist and this Act being
32 necessary for the immediate preservation of the public peace, health and
33 safety shall be in full force and effect from and after July 1, 1999.
