## Subtitle

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. REGULAR SALARIES. There is hereby established for the  
22 Department of Correction for the 1999-2001 biennium, the following maximum  
23 number of regular employees whose salaries shall be governed by the provisions  
24 of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201  
25 et seq.), or its successor, and all laws amendatory thereto. Provided,  
26 however, that any position to which a specific maximum annual salary is set  
27 out herein in dollars, shall be exempt from the provisions of said Uniform  
28 Classification and Compensation Act. All persons occupying positions  
29 authorized herein are hereby governed by the provisions of the Regular  
30 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its  
31 successor.

Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas Code 21-5-101), or its successor.

SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MEDICAL SERVICES - CONTINGENCY POSITIONS. If it has been *determined by the Board of Correction and Community Punishment* that the Department cannot continue a medical contract with a private provider and the Board deems it necessary to utilize Department staff to provide the required services, the Department is allowed, upon notification of the Chief Fiscal Officer of the State and after seeking prior review by the Arkansas Legislative Council or Joint Budget Committee, to utilize the contingent positions for medical services contained in Section 13 of this Act and make the appropriate transfers from the Professional Fees and Services line item contained in Section 3 of this Act to

1 Regular Salaries, Personal Services Matching and various Maintenance and  
2 General Operations classifications. *Further, the Department may utilize the*  
3 *service(s) of a state-based or national-based Professional Recruitment*  
4 *Service, or network, as may be necessary to recruit, fill, or maintain the*  
5 *occupancy of the positions stated herein.*

SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA SALARIES. USE OF MAINTENANCE AND OPERATION APPROPRIATION AND SALVAGED MATERIALS CONSTRUCTION. The Department of Correction is hereby authorized to utilize Maintenance and General Operation Appropriation in conjunction with surplus and/or salvageable materials for the purpose of implementing construction projects to benefit the Department and its various programs. Before such projects may be undertaken, a Method of Finance must be submitted for prior review by the Arkansas Legislative Council or Joint Budget Committee, and review and approval by the Department of Finance and Administration and the Arkansas State Building Services.

SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA SALARIES. There is hereby authorized, for the Department of Correction, for the ~~1997-99~~ 1999-01 biennium, the following increases in salaries for certain positions provided in the Regular Salary schedule in this Act, and to be in addition to the annual amounts as established by the Uniform Classification and Compensation Act, as amended, for full-time physicians who are certified by the American Specialty Boards at rates of pay not to exceed an additional \$4,500 per year. If certified in forensic psychiatry, an additional \$2,500 per year will be allowed. Total extra salaries may not exceed \$7,000 per year per position. In the event the physician is not a full time employee, the amount specified herein shall be adjusted proportionately to the amount of time worked for the Department of Correction by that physician.

SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COUNTY JAIL REIMBURSEMENT. In the event the Department of Correction cannot accept inmates from county jails due to insufficient bed space, the Department shall reimburse the counties at a rate determined by the Board of Correction and Community Punishment until the appropriation provided for such purpose is exhausted. The prevailing rate of the county jail will be considered by the Board in determining the rate to be reimbursed. The appropriation provided by Item (08) of Section 3 may also be used for contracts with county jails for

1 pre-release inmates.

9 of the State.

11 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER  
13 OF APPROPRIATION WITHIN CAPITAL IMPROVEMENT PROJECTS. The Department of  
14 Correction is hereby authorized to transfer appropriation between and/or among  
15 the various capital improvements/construction projects authorized by the  
16 General Assembly. Such transfers may be made only after approval by the  
17 Governor and after prior review by the Arkansas Legislative Council or Joint  
18 Budget Committee. Such authorization shall in no way mean that the total  
19 amount of funds or appropriations for capital improvement/construction  
20 projects be greater than that provided by the General Assembly for the  
21 Department of Correction.

23 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MENTAL  
25 HEALTH SERVICES. In the event the Department determines to enter into a  
26 professional contract for mental health services, the Department may, upon  
27 approval of the Chief Fiscal Officer of the State and after prior review by  
28 the Arkansas Legislative Council or Joint Budget Committee, make appropriate  
29 transfers from regular salaries, personal services matching and various  
30 maintenance and operation classifications to the professional fees and  
31 services classification for payment of the contractual amount.

33 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL  
35 REVENUE/CASH FUNDS TRANSFER. The Department of Correction is authorized to  
36 transfer funds from various Special Revenue and Cash Funds into the Inmate

1 Care and Custody Fund Account in order to adjust to the budget needs upon  
2 approval of the Board of Correction and Community Punishment and the Chief  
3 Fiscal Officer of the State.

5 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. NEW  
7 FACILITIES. If it is found that contracting for the operation of new  
8 facilities is economically beneficial to the State of Arkansas, the Department  
9 of Correction may, after receiving approval of the Chief Fiscal Officer, and  
10 seeking prior review by the Arkansas Legislative Council or Joint Budget  
11 Committee, transfer from any line item appropriation contained in Section 3 of  
12 this Act into the Professional Fees and Services line item contained in  
13 Section 3 of this Act to operate new facilities opened during the biennium.

14  
15 SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
17 APPROPRIATION TRANSFER FOR CONSTRUCTING AND EQUIPPING. The Department of  
18 Correction is hereby authorized to transfer appropriations between any line  
19 items authorized herein but only for the purpose of financing construction or  
20 equipment for a facility of the department. Any transfers authorized by this  
21 section shall require the approval of the Chief Fiscal Officer of the State  
22 after prior review by the Legislative Council or Joint Budget Committee.

23  
24 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
26 REALLOCATION OF RESOURCES. Upon determination by the Board of Correction and  
27 Community Punishment that a reallocation of resources within the Department of  
28 Community Punishment and Department of Correction is necessary for the  
29 efficient and effective operation of the departments, the Board, with approval  
30 of the Governor and *approval* by the Arkansas Legislative Council or Joint  
31 Budget Committee, shall have the authority to instruct the department  
32 directors, to request from the Chief Fiscal Officer of the State, a transfer  
33 of positions, programs, funds, appropriations, and line-item appropriations  
34 within or between existing and newly created divisions, offices, sections, or  
35 units of the departments. If it is determined that the requested transfer  
36 should be made, the Chief Fiscal Officer of the State shall then initiate the

1 necessary transfer documents to reflect the transfers upon the fiscal records  
2 of the State Treasurer, the State Auditor, the Chief Fiscal Officer of the  
3 State, and the Departments of Correction and Community Punishment. Provided,  
4 however, that the Board shall be limited to submitting no more than  
5 Four requests during any fiscal year. Transfer authority for unforeseen  
6 purposes shall further be limited to no more than five percent (5%) of the  
7 total appropriation, funding, and positions specific to each agency. Other  
8 than for unforeseen purposes, transfers shall be limited to the following  
9 specific purposes:

  - 16 f) Construction/renovation/equipping of new beds;
  - 17 g) Deficits in Farm or Industry Program;
  - 18 h) Losses not covered by insurance proceeds;
  - 19 i) Costs of personnel for critical services or necessary to carry out the  
20 mission of the agency.

21

22 Determining the maximum number of employees and the maximum amount of  
23 appropriation and general revenue funding for a state agency each fiscal year  
24 is the prerogative of the General Assembly. This is usually accomplished by  
25 delineating such maximums in the appropriation act(s) for a state agency and  
26 the general revenue allocations authorized for each fund and fund account by  
27 amendment to the Revenue Stabilization law. Further, the General Assembly has  
28 determined that the Department of Correction and the Department of Community  
29 Punishment may operate more efficiently if some flexibility is provided to the  
30 Board of Correction and Community Punishment authorizing broad powers under  
31 the Reallocation of Resources provisions herein. Therefore, it is both  
32 necessary and appropriate that the General Assembly maintain oversight by  
33 requiring prior approval of the Legislative Council or Joint Budget Committee  
34 as provided by this section. The requirement of approval by the Legislative  
35 Council or Joint Budget Committee is not a severable part of this section. If  
36 the requirement of approval by the Legislative Council or Joint Budget

1 Committee is ruled unconstitutional by a court jurisdiction, this entire  
 2 section is void.

3

4 SECTION 28. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HAZARDOUS  
 6 DUTY PAY. The Department of Correction is hereby authorized to pay hazardous  
 7 duty pay to provide special compensation to eligible security personnel to  
 8 compensate for the increased risk of personal injury. The hazardous duty pay  
 9 authorized herein shall not exceed an amount equal to five and one-half  
 10 percent (5.5%) of the annual salary authorized by law to any eligible employee  
 11 and shall only be made available to the personnel occupying the following  
 12 positions.

25 Employees assigned to these classifications may be eligible for hazardous duty  
 26 pay if the Director of the Department of Correction certifies to the Chief  
 27 Fiscal Officer that employees in these positions have been assigned direct  
 28 supervision of inmates which requires these positions to be exposed to  
 29 increased risk of personal injury.

30

31 Employees in the above classifications who are assigned to maximum security  
 32 lockup areas, i.e. administrative, segregation, punitive isolation and death  
 33 row at the maximum security unit, Varner Unit, Cummins Unit, and East Arkansas  
 34 Regional Unit, are authorized to receive the hazardous duty pay allowance and  
 35 an additional amount of maximum security incentive pay to five and one-half  
 36 percent of the annual salary authorized by law. This pay will only be paid

1 while the employee continues to work in the maximum security lockup areas and  
2 pay will be discontinued should the employee terminate work in this area.

3  
4 The amounts received under the provisions of this section shall not be  
5 considered as exceeding the maximum authorized annual salary allowance for  
6 employees in receipt of such amounts. Such amounts shall be considered as  
7 Regular Salary and the Department of Finance and Administration shall adopt  
8 the necessary rules and regulations for the administration of this provision.

9  
10 Employees covered by the provisions of this Section shall be eligible for  
11 special compensation for hazardous duty and additional compensation for  
12 maximum security assignment only upon a determination by the Chief Fiscal  
13 Officer of the State that sufficient general revenues are available to sustain  
14 payment of the additional compensation levels herein authorized. It is the  
15 intent of this section that such payments shall be optional, at the discretion  
16 of the Chief Fiscal Officer of the State and the Director of the Department of  
17 Correction, dependent upon sufficient revenues and shall not be implemented  
18 using funds specifically set aside for other programs within the Department.

19  
20 SECTION 29. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FOOD  
22 SERVICE CONTRACT. In the event the Department is able to contract with a  
23 private provider for food services at a unit(s), transfers may be made from  
24 Regular Salaries, Personal Services Matching, and Maintenance and Operations  
25 line items to Professional Fees and Services upon ~~notification~~ approval by the  
26 Chief Fiscal Officer of the State and after receiving prior review by the  
27 Legislative Council or Joint Budget Committee.

28  
29 SECTION 30. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LETHAL  
31 FENCE SALARY SAVINGS TRANSFER. In the event the Department of Correction is  
32 able to install a lethal electric fence around the perimeter of the states'  
33 institutions, a reduction of personnel currently stationed in towers could be  
34 realized. Any savings realized from reductions in Regular Salaries, Personnel  
35 Services Matching or other line items associated with the staff, may be  
36 transferred to appropriate line items for the installation, maintenance, and

1 operation of the electric fence upon approval by the Chief Fiscal Officer of  
2 the State after receiving prior review by the Arkansas Legislative Council or  
3 Joint Budget Committee.

4  
5 SECTION 31. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HOLIDAY  
7 COMPENSATION. The Department of Correction is authorized to pay employees for  
8 up to twelve (12) unused holidays exceeding a balance in the employee's  
9 holiday account of one-hundred fifty (150) hours following the end of the  
10 calendar year. Employees terminating employment from the Department of  
11 Correction will be eligible for all holiday pay accrued during the years of  
12 service. This request is contingent on approval by the Chief Fiscal Officer of  
13 the State after the Director of the Department of Correction has verified that  
14 sufficient revenues are available to make such payments to employees in the  
15 following classifications:

24 SECTION 32. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
26 INDEBTEDNESS REIMBURSEMENT. The Department of Correction is authorized to  
27 transfer funds from the Farm Fund to the Prison Industry Fund as may be  
28 necessary for reimbursement of a proportionate share of indebtedness.

29  
30 SECTION 33. APPROPRIATION - GENERAL IMPROVEMENT. *There is hereby*  
31 *appropriated to the Department of Correction, to be payable from the General*  
32 *Improvement Fund or its successor fund or fund accounts, the following:*

- 34 (A) *For costs associated with the lease of prison facilities for additional*
- 35 *prison beds, the sum of \$6,400,000.*

1 SECTION 34. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE  
2 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW. MEDICAL  
3 SERVICES - SPECIAL PROVISIONS FOR CERTAIN CLASSIFIED POSITIONS. The following  
4 patient care classified positions, L026 Dental Hygienist and L025 Dental  
5 Assistant, identified within Section 13 of this Act, may upon prior approval  
6 of the Chief Fiscal Officer of the State, be compensated at a rate up to Pay  
7 Level IV of the respective position classification.

8  
9 SECTION 35. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
10 by this act shall be limited to the appropriation for such agency and funds  
11 made available by law for the support of such appropriations; and the  
12 restrictions of the State Purchasing Law, the General Accounting and Budgetary  
13 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures  
14 and Restrictions Act, or their successors, and other fiscal control laws of  
15 this State, where applicable, and regulations promulgated by the Department of  
16 Finance and Administration, as authorized by law, shall be strictly complied  
17 with in disbursement of said funds.

18  
19 SECTION 36. LEGISLATIVE INTENT. It is the intent of the General Assembly  
20 that any funds disbursed under the authority of the appropriations contained  
21 in this act shall be in compliance with the stated reasons for which this act  
22 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
23 and Legislative Recommendations contained in the budget manuals prepared by  
24 the Department of Finance and Administration, letters, or summarized oral  
25 testimony in the official minutes of the Arkansas Legislative Council or Joint  
26 Budget Committee which relate to its passage and adoption.

27  
28 SECTION 37. CODE. All provisions of this Act of a general and permanent  
29 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
30 Code Revision Commission shall incorporate the same in the Code.

31  
32 SECTION 38. SEVERABILITY. If any provision of this act or the application  
33 thereof to any person or circumstance is held invalid, such invalidity shall  
34 not affect other provisions or applications of the act which can be given  
35 effect without the invalid provision or application, and to this end the  
36 provisions of this act are declared to be severable, *except as provided in*

1 Section 27 herein.

2

3 SECTION 39. GENERAL REPEALER. All laws and parts of laws in conflict with  
4 this act are hereby repealed.

5

6 SECTION 40. EMERGENCY CLAUSE. It is hereby found and determined by the  
7 Eighty-second General Assembly, that the Constitution of the State of Arkansas  
8 prohibits the appropriation of funds for more than a two (2) year period; that  
9 the effectiveness of this Act on July 1, 1999 is essential to the operation of  
10 the agency for which the appropriations in this Act are provided, and that in  
11 the event of an extension of the Regular Session, the delay in the effective  
12 date of this Act beyond July 1, 1999 could work irreparable harm upon the  
13 proper administration and provision of essential governmental programs.  
14 Therefore, an emergency is hereby declared to exist and this Act being  
15 necessary for the immediate preservation of the public peace, health and  
16 safety shall be in full force and effect from and after July 1, 1999.
