(a) The circuit judges of the First, Fourth, and Fifth Divisions of the 25 Sixth Judicial District may appoint one (1) presentence officer. 26 (b) The duties of the presentence officer shall include the 27 28 investigation of defendants and the making of such reports to the circuit 29 court as it deems desirable as to the past conduct of any defendant that 30 appears before the court. 31 (c) The salary of the presentence officer shall be fifteen twenty-three thousand dollars (\$15,000) (\$23,000) per calendar year, which salary shall be 32 paid by Pulaski County, Arkansas. 33 (d)(1) The salaries of the presentence officer set by this section and 34 by county ordinance shall be amended to provide for an increase of the minimum 35 salaries of four percent (4%) as of July 10, 1987; another increase of four 36
