## For An Act To Be Entitled

9 "AN ACT TO REPEAL ARKANSAS 2-40-827 WHICH WOULD HAVE  
10 SUNSET THE EQUINE INFECTIOUS ANEMIA LAW ON AUGUST 1,  
11 2000; *TO REVISE VARIOUS PROVISIONS OF THE EQUINE*  
12 *INFECTIOUS ANEMIA LAW; AND FOR OTHER PURPOSES. . "*

## Subtitle

15 "AN ACT TO REPEAL ARKANSAS 2-40-827 WHICH  
16 WOULD HAVE SUNSET THE EQUINE INFECTIOUS  
17 ANEMIA LAW ON AUGUST 1, 2000; *TO REVISE*  
18 *VARIOUS PROVISIONS OF THE EQUINE INFECTIOUS*  
19 *ANEMIA LAW. "*

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Arkansas Code 2-40-827 is repealed.

25 ~~2-40-827. Expiration of subchapter.~~

26 ~~The provisions of this subchapter shall sunset three (3) years from~~  
27 ~~August 1, 1997.~~

29 SECTION 2. *Arkansas Code Title 2, Chapter 40, Subchapter 8 is amended*  
30 *to add an additional section to read as follows:*

31 *"2-40-828. Reports of violations.*

32 *Any citizen may report to the commission an equidae that the citizen has*  
33 *reason to believe has not been tested as required by this subchapter."*

34  
35 SECTION 3. *All provisions of this act of a general and permanent nature*  
36 *are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code*

1 *Revision Commission shall incorporate the same in the Code.*

3 *SECTION 4. If any provision of this act or the application thereof to*  
4 *any person or circumstance is held invalid, such invalidity shall not affect*  
5 *other provisions or applications of the act which can be given effect without*  
6 *the invalid provision or application, and to this end the provisions of this*  
7 *act are declared to be severable.*

9 *SECTION 5. All laws and parts of laws in conflict with this act are*  
10 *hereby repealed.*
