19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. *Arkansas Code 21-8-701(a) is amended to read as follows:*

22 "(a) *The following persons shall file a written statement of financial*
23 *interest:*

24 (1) *A public official, as defined in subchapter 4 of this*
25 *chapter;*

26 (2) *A candidate for elective office;*

27 (3) *A municipal judge or city attorney, whether elected or*
28 *appointed;*

29 (4) *Any agency head, department director, or division director of*
30 *state government; and*

31 (5) *Any public appointee to any state board or commission who is*
32 *authorized or charged by law with the exercise of regulatory authority or is*
33 *authorized to receive or disburse state or federal funds;*

34 (6) All persons who are elected members of a school board or who
35 are candidates for a position on a school board; and

36 (7) Any person appointed to one (1) of the following types of

1 regional, municipal, or county boards or commissions:

2 (A) A planning board or commission;

3 (B) An airport board or commission;

4 (C) A water or sewer board or commission;

5 (D) A utility board or commission; or

6 (E) A civil service commission."

7
8 SECTION 2. All provisions of this act of a general and permanent nature
9 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
10 Revision Commission shall incorporate the same in the Code.

11
12 SECTION 3. If any provision of this act or the application thereof to
13 any person or circumstance is held invalid, such invalidity shall not affect
14 other provisions or applications of the act which can be given effect without
15 the invalid provision or application, and to this end the provisions of this
16 act are declared to be severable.

17
18 SECTION 4. All laws and parts of laws in conflict with this act are
19 hereby repealed.
