

If any provision of this act or the application thereof to 13 any person or circumstance is held invalid, such invalidity shall not affect 14 other provisions or applications of the act which can be given effect without 15 the invalid provision or application, and to this end the provisions of this 16 act are declared to be severable. 17 18 SECTION 4.
